





ORDER

Sh. Arjun Dev Grover, Mandi Supervisor, Market Committee, Hansi was placed under suspension vide order dated 23.07.2015 and he was charge sheeted under rule-7 of the HCS (P&A) Rules, 1987 vide memo No.C&E-III-1149/2016/57278 dated 02.08.2016. The following charges were levelled against him:-

- 1. That he has demanded bribe from Sh. Mohit Kumar in lieu of issue of license.*
- 2. That he has defamed the name of the organization.*
- 3. That he has violated the provision prescribed under rule 3(1) (i), (ii) & (iii), of the Haryana Government Employees (Conduct) Rules, 1966 and he has failed to perform his official duties honestly, sincerely and diligently.*

He submitted reply to the charge sheet vide letter dated 29.08.2016 wherein he has denied all the charges/allegations levelled against him.

After considering his reply, a regular departmental enquiry was entrusted to Sh. Roshan Lal, HCS (Retd.) vide memo dated 03.11.2016. The Enquiry Officer submitted his report on 30.01.2017 wherein he has submitted that the delinquent official is at fault, as the license was renewed in the name of Sh. Madan Lal (dead person) on the report/recommendation of delinquent official. He didn't verify the fact that Sh. Madan Lal has been already expired. The I.O. has further stated that Sh. Arjun Dev Grover is seen in video recording conversation, saying about 3 shopkeepers that it was the work of atleast Rs. One lakh. The person in video recording whom Sh. Arjun Dev Grover is talking is the Pradhan of Sabji Mandi, Hansi. The intension of the delinquent is clearly proved the demand of bribe in this case from Sh. Mohit Kumar on account of renewal/issuance of new license without verifying the facts and all the charges were proved against the delinquent.

Accordingly, a copy of enquiry report alongwith memorandum was issued to him vide memo dated 01.05.2017 to submit his representation within 30 days from the receipt of the communication. He submitted reply to the memorandum vide letter

dated 29.05.2017 reiterating the same version as he stated in his reply to the charge sheet and adduced nothing new.

After considering his reply, he was afforded an opportunity of personal hearing on 22.02.2019. During personal hearing, he stated that Sh. Mohit Kumar, the complainant was running affairs/business of the firm without license in the name of his father (expired on 13.11.2013) illegally. He didn't submit/produce any proof/documentary evidence in his defence.

After going through all the facts/evidence/enquiry report placed on the record and version taken during the hearing file, it is amply clear that the delinquent official demanded the bribe from the complainant for renewal/issuance of new license without verifying the facts as also evident from the CD submitted by the complainant. The Inquiry officer has also proved all the charges against him.

Therefore, I am of the opinion that he is guilty for demanding bribe from the complainant for renewal/issuance of new license without verifying the facts. Thus, continuation of Sh. Arjun Dev Grover, Mandi Supervisor in the service of HSAM Board is not in public interest. The delinquent is awarded punishment of "***Compulsory Retirement***" from service with immediate effect and same is quite in consonance with the gravity of mis-conduct committed by the delinquent.


