ORDER

An inspection of Market Committee, Charkhi Dadari was carried out by the then Chief Administrator Board consisting team of the ZMEO, H.S.A.M.Board, Rohtak, ZMEO, H.S.A.M.Board, Hisar and Secretary-cum-E.O., Market Committee, Karnal on 12.07.2016. While checking negligence on the part of Secretary-cum-E.O., Market Committee, Charkhi Dadri, the evasion at large scale in connivance with the subordinate staff was detected. Sh. Mohan, Auction Recorder, Market Committee, Charkhi Dadri was charge sheeted under rule-7 vide memo no. C&E-I-1296/2017/2438 dated 18.01.2017. The following charges were leveled against him:-

1. *That because of his connivance with the firms/dealers i.e. M/s. Shree Krishna Cotton & Oil Mill, market fee to the tune of Rs. 4,96,914/- was evaded by the said firms on the unaccounted stock of Sarson and Guar which was detected by the inspecting team.*
2. *That had the premises of said firms not checked by the inspecting team and unaccounted stock of Sarson and Guar not detected/pointed out, huge financial loss on account of evasion of Market fee would have been caused to the Board/Market Committee.*
3. *That, he has violated the provisions laid down under Rule 4(1) (i), (ii), (iii), (iv), 2(ii) and 3(i), (ii) & (iii) of the Haryana Civil Services (Employees' Conduct) Rules, 2016 and has failed to perform his duties sincerely & diligently.*

After considering his reply vide letter dated 14.02.2017 to the charge sheet, wherein he denied all the charges/allegations leveled against him, a departmental enquiry was entrusted to Sh. R.P. Bhasin, District and Sessions Judge (Retd.) vide order dated 08.05.2017, who submitted his findings on 19.12.2017 proving all the charges against Sh. Mohan, Auction Recorder. After considering the enquiry report, the delinquent was served a memorandum vide memo no. C&E-I-2017/1296/3103 dated 16.01.2018 to submit his representation within 30 days.

The delinquent official submitted his reply to the memorandum vide letter dated 15.02.2018 wherein he denied all the charges/allegations stating that he was deputed in Shri Krishna Cotton & Oil Mill and Shri Balaji Oil Mill from 12.04.2016 to 06.05.2016 to note down the arrival from morning to evening and entered the same in the gate register alongwith market fees. thereafter, the arrival was noted by the supervisory staff. During his duty, no stock of Gawar was available in the Krishna Cotton & Oil Mills, Gawar has been shown in the stock register only, in fact, Krishna Oil Mills and ~~Makrana~~

Gum Group & Chemical are different firms. The market fee on account of 9102.55 qtl. Gawar was deposited and this Gawar was placed in the premises of Makrania Gum Group & Chemical, these firms belong to same family. There is no processing machine for Gawar in the premises of Krishna Oil Mills, only processing machine for Sarson is available. Makrania Gum Group & Chemical is only the mill where Gawar is found, whereas market fee has been deposited from the Krishna Oil Mills. The delinquent was removed from his duties before 65 days, when the market fee on account of 1301 qtl Sarson was deposited from the Krishna Oil Mills,

There is lot of difference between his duty and checking, during this period irregularities can be made by the mills. The difference between physical verification and arrival entered in the stock in the said mills can be clarified by the officials who were deputed on the duties during that time. The Inquiry Officer has given importance to the prosecution and has ignored the facts given by the delinquent.

He was afforded an opportunity of personal hearing on 12.11.2018. During hearing, Sh. Mohan, Auction Recorder repeated the same version as stated in the reply of the charge sheet as well as memorandum.

After going through all the facts/evidence on the record and hearing arguments of the delinquent, I have come to the conclusion that it is amply clear that the reasons stated by him are not genuine and the charge of market fee is established on record. Though, the market fee alongwith penalty has been deposited in the Market Committee, Charkhi Dadri against the total market fee due against the Rice Millers. However, the detection of market fee and HRDF by the inspecting team is itself evidence in support of the doubt that he was connived in facilitating evasion of market fee with the dealers. Further, as per Section 33A of the HAPM Act of the Board, Auction Recorder can only assist the senior officers in checking of the stocks/records, only Secretary-cum-E.O. and Assistant Secretary empowered by the Board can check/inspect record of the mills. However, taking a lenient view, he is awarded punishment of 'Censure'.

An inspection of Market Committee, Charkhi Dadari was carried out by the then Chief Administrator Board consisting team of the ZMEO, H.S.A.M.Board, Rohtak. ZMEO, H.S.A.M.Board, Hisar and Secretary-cum-E.O., Market Committee, Karnal on 12.07.2016. While checking negligence on the part of Secretary-cum-E.O., Market Committee, Charkhi Dadri, the evasion at large scale in connivance with the subordinate staff was detected. Sh. Braham Parkash, the then Mandi Supervisor, Market Committee, Charkhi Dadri (Retd.) was charge sheeted under rule-7 vide memo no. C&E-I-1296/2017/2439 dated 18.01.2017. The following charges were leveled against him:-

1. *That because of his connivance with the firms/dealers i.e. M/s. Shree Krishna Cotton & Oil Mills and M/s. O.P. Cotton & Oil Mills, market fee to the tune of Rs. 13,19,532/- was evaded by the said firms on the unaccounted stock of Sarson and Guar which was detected by the inspecting team.*
2. *That had the premises of said firms not checked by the inspecting team and unaccounted stock of Sarson and Guar not detected/pointed out, huge financial loss on account of evasion of Market fee would have been caused to the Board/Market Committee.*
3. *That, he has violated the provisions laid down under Rule 4(1) (i), (ii), (iii), (iv), 2(ii) and 3(i) of the Haryana Civil Services (Employees' Conduct) Rules, 2016 and has failed to perform his duties sincerely & diligently*

After considering his reply vide letter dated 08.02.2017 to the charge sheet, wherein he denied all the charges/allegations leveled against him, a departmental enquiry was entrusted to Sh. R.P. Bhasin, District and Sessions Judge (Retd.) vide order dated 08.05.2017. who submitted his findings on 13.11.2017 proving all the charges against Sh. Braham Parkash, Mandi Supervisor. After considering the enquiry report, the delinquent was served a memorandum vide memo no. C&E-I-2017/1296/2117 dated 11.01.2018 to submit his representation within 30 days.

The delinquent official submitted his reply to the memorandum vide letter dated 26.02.2018 and denied all the charges/allegations stating that during his duty he inspected all the firms honestly as a result of which market fees was more than comparatively last year 3%. As per PAMP, Act, 1961 under section 33-A of the H.S.A.M.Board, no Mandi Supervisor and Auction Recorder can check the record of the dealer except Secretary-cum-E.O., DMEO and ZMEO. However, these officers neither checked any mill from 01.04.2016 to 11.07.2016 nor checked any record of the mills, this fact can be verified from the movement

register, log book and from the registers of the mills. This market fee was deposited merely to show as paper transaction. The intimation/report with regard to supply the names of the defaulting officials by the ZMEO, H.S.A.M.Board, Hissar was not prepared fairly. The delinquent is not satisfied with the departmental enquiry.

He was afforded an opportunity of personal hearing on 12.11.2018. During hearing, Sh. Braham Parkash, Mandi Supervisor repeated the same version as stated in the reply of the charge sheet as well as memorandum.

After going through all the facts/evidence on the record and hearing arguments of the delinquent, I have come to the conclusion that it is amply clear that the reasons stated by him are not genuine and the charge of market fee is established on record. Though, the market fee alongwith penalty has been deposited in the Market Committee, Charkhi Dadri against the total market fee due against the Rice Millers. However, the detection of market fee and HRDF by the inspecting team is itself evidence in support of the doubt that he was involved in facilitating evasion of market fee with the dealers.
