

Sh. S.K. Goel, the then Executive Engineer now Superintending Engineer (Retd.) was charge sheeted under rule-7 of the Haryana Civil Services (Punishment and appeal) Rules, 1987 vide this office memo No C&E-II/1658/2008/14986 dated 03.03.2008 and the following charges were levelled against him:-

1. That he failed to exercise proper inspection over the work during execution and not imparted any instructions for achieving good quality of work thereby committing a wasteful expenditure of Rs.09.37 lacs with malafide intention.
2. That he violated the provision laid in the PWD Manual of Orders, Work Procedure of the Board and thus, violated the provisions laid down in the Rule 3.(i),(ii) & (iii) of the Government Employees (Conduct) Rules, 1966.
3. That he failed to perform his official duties honestly, sincerely and diligently.

The charged officer submitted reply to the charge sheet vide letter dated 04.04.2008 and denied all the charges leveled against him on the ground that he has done all maximum to carry out the inspection of work in all sincerity. There is no cause and occasion for any wasteful expenditure as per position in the statement of allegations. There is no truthfulness and rather it is an unfortunate stigma that some malafide intention was involved. He also stated that he has not violated any provisions of the PWD Manual of Orders and there is absolutely no violation on his part. He has nowhere infringed the provisions of work procedure of the Board as has been alleged against him. He has always maintained absolute integrity and has always maintained full devotion to duty and has done nothing which could be considered as unbecoming of a Government employee. Thus, he was not at fault in this case.

The reply of the charged officer was not considered because he had already been dismissed in another case vide order dated 22.04.2008, as he was caught red handed while taking illegal gratification of Rs.5200/- and an FIR No.120 under Section 7/13/49/88 of PC Act, 1988 was registered against him in police station at Jagadhri on 24.04.2001. In this case, the Hon'ble Court of ADJ, Yamuna Nagar at Jagadhri vide order dated 18.09.2002 held him guilty and awarded the punishment of sentence to undergo rigorous imprisonment of two years and to pay a fine of Rs.2000/-. In default of payment of fine, he shall further undergo rigorous imprisonment for 6 months. Sh. S.K. Goel filed an appeal before Hon'ble

High Court against the order dated 18.09.2002. The Hon'ble High Court vide order dated 08.10.2002 suspended the sentence awarded to him during the pendency of appeal, as he was already on bail upto 18.10.2002.

The charged officer vide his representation dated 22.08.2014 requested to release his retiral benefits as his case has already been decided by the Hon'ble High Court vide order dated 17.12.2012 as under:-

"This appeal is allowed, judgment of conviction 17.09.2002 and orders of sentence dated 18.09.2002 are set aside and the appellant is acquitted from the charges framed strictly in consonance with the observations and authority of law laid down by the apex Court in the case of Banarsi Dass (Supra)".

On the decision dated 17.12.2012 and representation dated 22.08.2014, the matter was examined and the regular departmental enquiry was entrusted to Sh. Roshan Lal, HCS (Retd.) vide order dated 09.09.2016 who submitted his report vide letter dated 02.03.2017 wherein none of the charges have been proved against him.

The enquiry report was placed before the Administrative Committee in its meeting held on 07.11.2017 for confirmation of order of appointment of I.O./P.O. dated 09.09.2016 passed by the Chief Administrator, Board and consideration of enquiry report and decision thereof. The Committee confirmed the orders of Chief Administrator dated 09.09.2016 for appointment of I.O./P.O. The Committee considered the enquiry report in detail and disagreeing with the enquiry report, decided to send a copy of enquiry report alongwith dissenting note to the charged officer to submit his representation. The Committee also desired to call the charged officer for personal hearing in the next meeting of the Committee. Accordingly, a copy of the enquiry report alongwith dissenting note was sent to the charge officer vide memo dated 24.11.2017 with the directions to submit his objections/reply within 21 days.

The charged officer submitted his objections vide letter dated 15.12.2017 and denied all the charges leveled against him stating that:-

The competent authority has failed to appreciate that earth work was carried out by a different department i.e. Development & Panchayati Raj Deptt. and the officers/officials of the HSAMB had no role to play because the said work had to be supervised by the Engineering Wing of the said department including their C.E., S.E. & XEN etc. The compaction of earth at all its layers of 20 CMs is not possible after completion of the whole earth work by the said department and this fact had been admitted by the solitary department witness in his cross-examination. He has also stated that imparting any instructions in this regard was not possible

particularly when the site was handed over by the said department after completion of earth work. He has also stated that he issued instructions for compaction of earth at all its layers of 20CMs as per the PWD specifications.

He has further stated that he cannot be held responsible for not imparting instructions to the subordinate staff comprising XEN, SDE and JE who are directly involved in carrying out these works at site. He has requested to exonerate him from the charges and if still there is any doubt about the same, he may be heard in person.

The objections/reply submitted by the charged officer was placed before the Administrative Committee in its meeting held on 19.12.2017 vide agenda item No.04. The case was considered and decided by the Administrative Committee as under:-

“Sh. S.K. Goel appeared before the committee for personal hearing and stated that no charge has been proved against him. He further requested to drop the charge sheet against him.

The Committee discussed the matter at length and considered the enquiry report, reply of dissenting note, all other relevant papers and verbal assertions of the appellant. After due deliberations, the committee observed that Sh. S.K. Goel failed to exercise proper inspection over the work during execution and not imparted any instruction for achieving good quality of work resulting in wasteful expenditure of Rs.8.61 lacs on the work with malafide intention. Thus, he cannot go scot free in this case. However, taking a lenient view, the committee decided to award punishment of recovery of 5% amount of total loss of Rs.8,61,003/- to him.”

Sh. S.K. Goel, the then Executive Engineer now Superintending Engineer (Retd.) was caught red handed while taking illegal gratification of Rs.5200/- and an FIR No.120 under section 7/13/49/88 of PC Act,1988 was registered against him in police station at Jagadhri on 24.04.2001. He remained under judicial custody from 24.04.2001 to 28.04.2001. He was placed under suspension vide order dated 25.04.2001. He was charge sheeted under rule-7 on 08.01.2002 and the following charge was leveled against him:

- 1 That he accepted illegal gratification of Rs.5200/- from Sh. Ramesh Chander S/o Sh. Shanti Parkash Aggarwal, resident of house No.1721, Sector-17 HUDA Colony, Jagadhri.

The charged officer submitted reply to the charge sheet vide letter dated 16.04.2002 and denied the charge leveled against him. He was reinstated vide order dated 26.04.2002 subject to final outcome of FIR/Court case and without prejudice to the pending departmental enquiry against him.

The reply of the charged officer was considered by the competent authority and was found unsatisfactory. The enquiry was entrusted to Sh. Roshan Lal, HCS, (Retd.) vide order dated 09.09.2016, who submitted his report vide memo dated 02.03.2017, wherein the charge leveled against him has not been proved.

The enquiry report was placed before the Administrative Committee in its meeting held on 07.11.2017 for confirmation of order of appointment of I.O./P.O. dated 09.09.2016 passed by the Chief Administrator, Board and consideration of enquiry report and decision thereof. The Committee confirmed the orders of Chief Administrator dated 09.09.2016 for appointment of I.O./P.O. The Committee considered the enquiry report in detail and disagreeing with the enquiry report decided to send a copy of enquiry report alongwith dissenting note to the charged officer to submit his representation. The Committee also desired to call the charged officer for personal hearing in the next meeting of the Committee.

Accordingly, a copy of the enquiry report alongwith dissenting note was issued vide memo dated 24.11.2017 with the direction to submit objections within 21 days.

The charged officer submitted his objections vide letter dated 15.12.2017 and denied all the charges leveled against him stating that:-

As per Rule-7 (B) (2) of the Haryana Civil Services (P&A) Rules, 2016, each finding of guilt should be supported by reasons and evidence led in the inquiry. Similarly, the competent authority is to form his opinion on the basis of evidence led in the Inquiry only. He has stated that there was no evidence led by the Deptt./Presenting Officer during Inquiry. This is a case of no evidence. Therefore, it is ipse dixit of the competent authority to hold him guilty on the charge that he accepted illegal gratification of Rs.5200/- from Sh. Ramesh Chander. The Hon'ble Supreme Court had held in the case of Roop Singh Negi Vs. Punjab National Bank 2009 (2) SCC 570 that

"10 ... The charges leveled against the delinquent officer must be found to have been proved. The enquiry officer has a duty to arrive at a finding upon taking into consideration the materials brought on record by the parties. The purported evidence collected during investigation against all the accused by itself could not be treated to be evidence in the disciplinary proceeding. No witness was examined to prove the said documents. The management witnesses merely tendered the documents and did not prove the contents thereof. Reliance, inter alia, was placed by the enquiry officer on the FIR which could not have been treated as evidence.

17 ....The materials brought on record pointing out the guilt are required to be proved. A decision must be arrived at on some evidence, which is legally admissible. The provisions of the Evidence Act may not be applicable in a departmental proceeding but the principles of natural justice are. As the report of the Enquiry Officer was based on merely ipse dixit as also surmises and conjectures, the same could not have been sustained. The inferences drawn by the Enquiry Officer apparently were not supported by any evidence. Suspicion, as is well known, however high may be, can under no circumstances be held to be a substitute for legal proof."

He has also quoted some other decisions of Hon'ble Supreme Court i.e. State of UP Vs. Saroj Kumar Sinha 2010 (2) SCC 772 and Brij Bihari Singh Vs. Bihar State Financial Corporation 2016 (1) SCT 138. He has also stated that it is abundantly clear that finding of the competent authority is not on the basis of any evidence led in the Inquiry and as such, the same is wholly perverse keeping in view the fact that no evidence was led by the Deptt./Presenting Officer during the Inquiry to substantiate the charge leveled against him. This is case of no evidence.

He has also stated that the competent authority travelled beyond the charge leveled against him which is that he accepted illegal gratification of Rs.5200/- from Sh. Ramesh Chander. The competent authority has stated about the work of 'L/R from Village Dhanauri to Village Khanpur Rajputan'. He

has further stated that he submitted detailed estimate to the SE for technical sanction after a lapse of about 7 months of allotment and work should not be got started by him without approval and that he released 75% security of the work without approval of the detailed estimate.

That neither material has been brought on the Inquiry file about the above nor the same is relevant with charge, but as per records/ facts, the department itself stated in the charge sheet dated 08.01.2002 that he was posted at Y-Nagar on 10.10.2000 and the works were allotted already by executing contract between the Deptt. and the contractor; therefore, there is no question of any delay on his part and even monthly payment had to be released in terms of the Contract when a contractor executes his work.

He has also stated that the suspicion cannot take shape of proof. The competent authority has given its reasoning by relying upon foreign material and held that "There is evidence of doubts about his integrity and irregular working." No person can be held guilty merely on doubts. There must be definite and concrete material on the Inquiry file to hold a person guilty. He has further stated that the competent authority had relied upon the observations of the judgment dated 17.09.2002 of Ld. Additional Sessions Judge, Y-Nagar to the effect that he was held guilty by the said Criminal Court on the basis of statement of Deputy Superintendent of Police and Sub Divisional Magistrate despite the fact that the complainant and shadow witness were declared hostile. He has also stated that the judgment was set aside by the Hon'ble High Court in its judgment dated 17.12.2012 because of aforesaid error on the part of Ld. Trial Court.

He has also stated that "Recovery of the alleged tainted notes has been effected from the drawer of the table and not from the pocket of the appellant. The recovery further became doubtful. The office of the appellant was open to everyone specially staff, so in connivance with staff such tainted money can be placed in the drawer of the table too. He was finally acquitted by the Hon'ble High Court from the charge by its judgment dated 17.12.2012. Therefore, it cannot be said that he was acquitted by giving any benefit of doubt.

He has also quoted various decisions of Hon'ble High Court i.e. judgment dated 07.12.2004 in case of Shashi Kumar Vs. UHBVN 2005 (1) SCT 576, Bhag Singh Vs. Punjab & Sind Bank 2006 (1) SCT 175, Punjab National Bank and others V. Kunj Behari Misra, 1998 (3) SCT 833 and Haryana State Agricultural Marketing Board Vs. K.L. Ahuja 2011 (4) SCT 233.

He has also stated that from the above, it is quite clear that he has been rightly absolved of the charge by the Inquiry Officer and has requested to


exonerate him from the charge. If still there is any doubt about the same, then personal hearing may be granted.

The objections/reply submitted by the charged officer was placed before the Administrative Committee in its meeting held on 19.12.2017 vide agenda item No.03. The case was considered and decided by the Administrative Committee as under:-

"Sh. S.K. Goel appeared before the committee for personal hearing and stated that no charge has been proved against him. He further requested to drop the charge sheet against him, moreover he has been acquitted by the Hon'ble Court and the order dated 22.04.2008 vide which he was dismissed from the service of the board has been quashed with the direction to pay arrears of salary and remaining benefits etc. He further requested to drop the charge sheet against him.

The Committee discussed the matter at length and considered the reply of the dissenting note and various orders of the Hon'ble Court. The Committee observed that the judgment of conviction dated 17.09.2002 and order of sentence dated 18.09.2002 have been set aside and the appellant has also been acquitted of the charge by the Hon'ble Court vide order dated 17.12.2012. Moreover, the order dated 22.04.2008 of his dismissal has been quashed by the Hon'ble court 14.01.2016 and the charge leveled in the charge sheet has not been proved against him. In view of the above facts, committee decided to drop the charge sheet issued vide memo dated 08.01.2002. The committee also decided that his suspension period from 24.04.2001 to 25.04.2002 be treated as period spent on duty for all intents and purposes."






