Sh. Naveen Dahiya, Executive Engineer was charge sheeted under rule-7 of the HCS (P&A) Rules, 2016 vide this office memo No. C&E-II/2142/2018/60257 dated 04.09.2018 and the following charges were levelled against him:-

- 1 That he has allowed/released payment of less consumed bitumen, 8.53 MT @ 36,409 per MT for Rs.6,21,138/- at penal rate in the 10th R/bill and caused financial loss to the Market Committee/Board.
- 2 That he in connivance with the Sub Divisional Engineer/Junior Engineer/Agency released the payment of less used of bitumen and caused financial loss to the Market Committee/ Board.
- 3 That he has failed to exercise proper control over the work at site in order to achieve good quality of work as approved in the DNIT/specifications.
- 4 That he has acted in an unprofessional and irresponsible manner and miserably failed to perform his assigned official duties properly.
- 5 Thus, he has failed to perform his official duties honestly, sincerely and diligently & has violated the provisions laid down under Rule 3(II) (ii) & (iii) of the Work Procedure of the Board & PWD Manual of Orders, 5.5 and Haryana PWD Code, 2009 rule 6.6 & para No. 20.5.1 and Rule 4(1) (i), (ii), (iii), (iv) and 4(2) (ii) of the Haryana Civil Services (Government Employees' Conduct) Rules, 2016.

In the meantime, Sh. Naveen Dahiya, XEN gave a representation dated 21.07.2018 stating that the work was inspected by the SVB (H) on 22.04.2015 and twelve nos. representative samples were collected and got tested from FSL (H) Madhuban. As per test results in sample no. 1, 7 & 11 of stone soling, Gr.-II, the maximum average variation in percentage weight passing of stone aggregate was found 38.47% at sieve size 45m. So, for 12cum quantity of work @300/- per cum (basic quarry rate) + 38.47% (variation), the recovery amounting to Rs. 5,32,140/- was to be made from the agency and suitable departmental action was recommended against S/Sh. S.S. Arora, XEN, G.L. Malik, SDE, and Satyawan, JE for this loss/lapses.

As per test result of sample No. 4, 8 & 12 of stone soling Gr.-I, the maximum average variation in percentage weight passing of stone aggregate was found 18.60% at sieve size 63mm. So, for 1098cum quantity of work @275/- per cum (basic quarry rate) + 18.60% (variation), the recovery amounting to Rs. 3,58,113/- was to be made from the agency and suitable departmental action was recommended against S/Sh. S.S. Arora, XEN, G.L. Malik, SDE and Satyawan, JE for this loss/lapses.

He further stated that he joined the duty of XEN as additional charge of Panipat division and remained posted there only for 41 days. During his incumbency, only the work of premix carpet was executed and samples were got tested form Micro Engineering and Testing lab and were found well within



the permissible limit. Whereas, the samples collected by SVB (H) were tested after lapse of 2 years. Thus, it is not possible that quantity and quality of bitumen will be found 100%. The quantity of bitumen is calculated by imposing requirement of bitumen 4.75% in premix carpet with tack & seal coat instead of (4.20% +) which is completely wrong. He finally stated that no loss has been occurred and requested to drop the charge sheet.


His representation was sent to the Technical Advisor who submitted his comments on 17.12.2018 stating that SBV (H) while computing their inspection report have considered a penal rate on the recovery of less consumption of bitumen used by the agency, whereas penal rates are only imposed when the bitumen is supplied by the Deptt. But in this case, the bitumen has been arranged by the contractor at his own cost. Hence, no penal rate recovery should have been considered as recommended by the SVB (H). An amount of Rs.4,62,016/- was released as security by S/Sh. Mohinder Singh, XEN, R.P. Bhardwaj, S.D.E (Retd.), Satyawan, J.E., Rajesh, Accountant without waiting the SVB report, which should have been mandatory.

Against the loss of Rs.15,11,351/- worked out by the SVB (H), the Technical Advisor has worked out the loss to the tune of Rs.4,45,601/-. From this amount, the amount of loss attributable to Sh. Naveen Dahiya has been shown to the tune of Rs.21,996/-.

The matter was placed before the Administrative Committee in its meeting held on 20.12.2018 for confirmation of orders dated 28.05.2018 of the C.A. to issue charge sheet under rule-7 against Sh Naveen Dahiya and rule 12(2)(b) against the retiree (Sh. S.S. Arora) and consideration of reply and appropriate decision. The case was considered and decided by the Administrative Committee as under:-

"The order dated 28.05.2018 of Chief Administrator for charge sheeting the XENs was confirmed. The matter was discussed in detail. The Committee also discussed the comments furnished by Technical Advisor on the representation dated 21.07.2018 given by Sh. Naveen Dahiya, XEN. The Technical Advisor has worked out the loss to the tune of Rs.4,45,601/- against the loss of Rs.15,11,351/- worked out by the SVB (H). From this amount, the amount of loss attributable to Sh. Naveen Dahiya, XEN has been shown to the tune of Rs.21,966/-. Thus, the committee decided to close the disciplinary proceeding against Sh. Naveen Dahiya, XEN by recovery of loss of Rs.21,966/-."
