Shri Babu Lal, Head Clerk was issued charge sheet under Rule 8 of the Haryana Civil Services (Punishment & Appeals) Rules, 1987 vide this office Memo No. C&E-II-1915/2014/50896 dated 19.06.2014 with following allegations:-

*"That the Internal Audit of Bhiwani Division, for the period 04/2007 to 03/2011 was conducted by the Audit party from 14.11.2011 to 02.12.2011. The Internal Audit report containing 12 paras was issued to the Executive Engineer, Bhiwani vide No. Accts/I.A/2011-12/7099 dated 31.01.2012 for furnishing the reply in an annotated form within one month, but no reply was submitted despite reminders dated 29.02.2012, 19.06.2012, 16.01.2013 and 20.04.2013. Para No. 2 of the report brings out 'Excess payment of Rs.0.80 lacs due to non recovery of collection charges from labour Cess'.*

*After receipt of Audit report, the competent authority orders to issue charge sheet under rule-8 to Divisional Accountant/Supdt. and Executive Engineer who is responsible for over payment of Rs.88,355/-That (Sh. Babu Lal) Head Clerk & Executive Engineer, of Bhiwani Division was asked vide this office memo No. C&E-II-1915/2013/75590 dated 25.11.2013 to submit the name of defaulting Executive Engineer, Divisional Accountant and Head Clerk concerned who did not deduct the labour cess @ 1% while releasing the payment to concerned department. Further, he was also asked to prepare and submit draft charge sheets, documentary proof, evidence and name of witnesses with full facts of the case within 7 days through special messenger. But no draft charge sheets as well as names were supplied by him despite reminder dated 24.12.2013 and 02.01.2014 He was also finally directed to submit the draft charge sheets, failing which disciplinary action will be initiated against him vide memo dated 01.04.2014, but he failed to submit the same.*

*That he (Sh. Babu Lal) had failed to comply with the directions/instructions issued by the Head-Office for submitting the names of defaulting officers/officials. This shows his negligent and irresponsible attitude towards important work and delayed the matter intentionally.*

Thus, he has violated the provisions prescribed in Para 3(1) (ii) & (iii) of the Government Employees (Conduct) Rules, 1966. Thus, he remained negligent in discharging his official duties sincerely, honestly and diligently."

He was asked to submit the reply within 15 days from the receipt of memorandum. The delinquent official submitted his reply to the charge sheet vide letter dated 04.07.2014 and denied all the allegations made against him stating that:-

"On the subject cited above it is brought to your kind notice that the Labour Cess @ 1% was deducted from the running bill of the contractual agencies and whole amount was being deposited with the Secretary, Haryana Building & other Construction Work Welfare Fund at Chandigarh, but out this amount 1% collection charged was not deducted by the Accounts Branch without instructions issued by the authority. After some time the than Divisional Accountant has told verbally that 1% collection charges will be deducted from the bill of the agency decided in meeting at Head Quarter Panchkula with the Worthy C.F.A.

Now 1% collection charges i.e. Rs.88,355/- has been deducted out of labour cess after obtaining prior permission from the Board vide his memo no. 45933 dated 29.05.2014 which has already been intimated to your good office vide T/o memo no. 7151 dated 06.06.2014. The name of the concerned officers/officials has already been sent to the Head Officer, Panchkula vide T/o memo no. 6381 dated 18.04.2014. Now, the same is also sent to the Head officer vide T/o memo no. 7485 dated 04.07.2014.

In this connection, I humbly prayed with your goodself kindly consider my request and exempt to me for this punishment at the earliest possible please. I shall be highly thankful to you for this act of kindness."

After considering his reply, an opportunity of personal hearing was also given to the delinquent before the final disposal of this charge sheet.

The delinquent official appeared in this office and reiterated the same version as he stated in his reply. He further stated that the matter was also discussed many times with the CFA and finally the Board vide memo dated 29.05.2014 allowed to recover the amount i.e. Rs.88,335/- and same was adjusted from the payments made to the Secretary, Haryana Building and other construction works Welfare Fund, Chandigarh and also stated that there is no loss to the Market Committee/Board. He also shown the copy of letter dated 16.04.2014 vide which the Executive Engineer, Bhiwani had sent the name of the incumbents when the

collection charges were not deducted. He also submitted that he has retired from the services by superannuation on 28.02.2017 and therefore, his case may be considered sympathetically and the charge sheet may be dropped.

After hearing the arguments and the perusal of relevant record, it is evident that the requisite information regarding incumbent officers/officials was sent by the XEN, Bhiwani vide letter dated 16.04.2014. However, the said fact was not properly appreciated at the time of issuance of the charge sheet in question. Moreover, the collection charges have already been recovered by adjustment from the other payments of the Secretary, Haryana Building and other construction works Welfare Fund, Chandigarh and no loss has been caused to the Board. Further, the delinquent has already retired on 28.02.2017.

In view of the above, the charge sheet is hereby dropped.



Shri Rajesh Kumar, Executive Engineer was issued charge sheet under Rule 8 of the Haryana Civil Services (Punishment & Appeals) Rules, 1987 vide this office Memo No. C&E-II-1915/2014/50895 dated 19.06.2014 with following allegations:-

*"That the Internal Audit of Bhiwani Division, for the period 04/2007 to 03/2011 was conducted by the Audit party from 14.11.2011 to 02.12.2011. The Internal Audit report containing 12 paras was issued to the Executive Engineer, Bhiwani vide No. Accts/I.A/2011-12/7099 dated 31.01.2012 for furnishing the reply in an annotated form within one month, but no reply was submitted despite reminders dated 29.02.2012, 19.06.2012, 16.01.2013 and 20.04.2013. Para No. 2 of the report brings out 'Excess payment of Rs.0.80 lacs due to non recovery of collection charges from labour Cess'.*

*After receipt of Audit report, the competent authority orders to issue charge sheet under rule-8 to Divisional Accountant/Supdt. and Executive Engineer who is responsible for over payment of Rs.88,355/-That (Sh. Rajesh Kumar) Executive Engineer and Head Clerk of Bhiwani Division was asked vide this office memo No. C&E-II-1915/2013/75590 dated 25.11.2013 to submit the name of defaulting Executive Engineer, Divisional Accountant and Head Clerk concerned who did not deduct the labour cess @ 1% while releasing the payment to concerned department. Further, he was also asked to prepare and submit draft charge sheets, documentary proof, evidence and name of witnesses with full facts of the case within 7 days through special messenger. But no draft charge sheets as well as names were supplied by him despite reminder dated 24.12.2013 and 02.01.2014 He was also finally directed to submit the draft charge sheets, failing which disciplinary action will be initiated against him vide memo dated 01.04.2014, but he failed to submit the same.*

*That he (Sh. Rajesh Kumar) failed to comply with the directions/instructions issued by the Head-Office for submitting the names of defaulting officers/officials. This shows his negligent and irresponsible attitude towards important work and delayed the matter intentionally.*

Thus, he has violated the provisions prescribed in Para 3(I) (ii) & (iii) of the Government Employees (Conduct) Rules, 1966. Thus, he remained negligent in discharging his official duties sincerely, honestly and diligently."

He was asked to submit the reply within 15 days from the receipt of memorandum. The delinquent officer submitted his reply to the charge sheet vide letter dated 31.07.2014 and denied all the allegations stating that:-

"It is respectfully submitted that I have been issued charge sheet under Rule -8 HCS (P&A) vide memo no. C&E-II-1915/2014/50895 dated 19.06.2014, on the wrong and fictitious grounds without consulting the relevant record of this case and without any basis. Even the explanation required to be called which is mandatory as per coddle provisions in the rules is not called for in the matter to clear my position in this case.

In this regard, I would like to draw your kind attention towards the facts of this case and its back ground enabling to understand the factual position of the entire matter. That the Internal audit was conducted of Bhiwani Division for the period 4/2007 to 03/2011 by the Audit party from 14.11.2011 to 02.12.2011 in which para No.2 of the report brings out "Excess payment of Rs.0.88 lacs" due to non-recovery of collection charges from labour cess.

As per your good office memo no. 75590 dated 25.11.2013, 83294 dated 24.12.2013, 2075 dated 02.01.2014 and 29022 dated 01.04.2014, every time it was stated that labour cess @ 1% during releasing the payment of concerned agencies was not deducted which is totally wrong. The labour cess @1% during releasing the payment of concerned agencies was made regularly by Division office and the same was deposited to the concerned dept., i.e. "Secretary, Haryana Building and other construction works Welfare Fund, 30 Buys Building, Sector-17-B, Chandigarh, however the collection charges which are @1% of total cess i.e. Rs.88,335/- was not made during that time to non-confirmation of order and due to no clear-cut guidelines regarding collection charges. The matter was also discussed verbally many times with your good office by undersigned as well as Accountant and Head Clerk of Bhiwani Division and after discussion, it was decided that the dues may be recovered at this time also from the on-going payments and requested to allow to recover the amount alongwith the name of concerned officers/officials were sent to your good office vide E.E. office memo no. 6381 dated 16.04.2014 (Annexure-I) and your good office vide

memo no. 45933 dated 29.05.2014 (Annexure-II) allowed Executive Engineer, HSAM Board, Bhiwani to recover the amount i.e. Rs.88,335/- which is shown in cash book of May, 2014 (Annexure-III) and the recovery thus made has already been intimated to your good office vide T/o endst. no. 7151 dated 06.06.2014 (Annexure-IV). As the name of officers/officials had already been made intimated vide T/o memo no. 6381 dated 16.04.2014 (Annexure-I) and recovery has already been made after taking prior approval from the competent authority of the Board, so proper procedure was adopted for this and no negligency was made by undersigned in this regard."

Hence, the charge is itself vogue as no provision/para of work procedure has been mentioned under this charge which has been violated by me. Moreover, violation of all rules quoted under 3(I) (ii) & (iii) of the Government Employees (Conduct) Rules, 1966 are not applicable in this case because in this case nothing has been done dishonestly and negligently an every effort has been made by the undersigned by proper channel taking prior approval from the competent authority and the recovery of Rs. 88,355/- has already been made form the dues of "Secretary, Haryana Building and other construction works Welfare Fund, 30 Buys Building, Sector-17-B, Chandigarh".

In view of above, it is for kind consideration that it would be an injustice to me if I am alleged for act of omission and commission, misconduct and dereliction of duty, so I do not become liable for any disciplinary action not to mention of its severe penalty.

It is therefore that my reply submitted in the matter may please be considered sympathetically and I may be exonerated from the charges leveled against me."

After considering his reply, an opportunity of personal hearing was given to the delinquent before the final disposal of this charge sheet.

The delinquent official appeared in this office and reiterated the same version as he stated in his reply. He further stated that the matter was also discussed many times with the CFA and finally the Board vide memo dated 29.05.2014 allowed to recover the amount i.e. Rs.88,335/- and same was adjusted from the payments made to the Secretary, Haryana Building and other construction works Welfare Fund, Chandigarh and also stated that there is no loss to the Market Committee/Board. He also shown the copy of letter dated 16.04.2014 vide which he had sent the name of the incumbents when the collection charges were not deducted. He also submitted

Description of duties of above mentioned officials:-

Duties of Nodal Officer and Asstt. Nodal Officers of HSAMB for transportation of farmers:

- They will be responsible for transportation of atleast 50 farmers per day per bus to the venue as per the buses allocated to their respective districts.
- The concerned Nodal officer will ensure that a SMC rank official should accompany the buses carrying farmers at the summit site throughout the event to ensure proper participation of the farmers in the summit. The SMC-cum-Incharge of the bus will also report to the CMEO, HSAMB at the summit site.
- They will be in regular touch with the concerned DDA (Deputy Director Agriculture) who will arrange and provide buses.
- Lunch of farmers will be provided at the Agri. Leadership Summit Site for which 54 coupons of lunch per bus will be provided by the concerned Nodal Officer/Asstt. Nodal officer at the time of departure of buses.
- They will ensure that the banner be collected from the agency engaged for organizing the summit and the same should be properly pasted on the buses of their respective districts coming to the Summit.
- They will ensure to take the registration form from the concerned DDA (Deputy Director Agriculture) and thereafter supply the same to all the Bus Incharges.
- They will monitor timely departure of the buses from their respective districts.

Duties of Bus Incharges of HSAMB:

- They are the Group Leaders in the Buses & will do the registration of the farmers to be boarded in the bus in the "registration form" provided by the concerned Nodal Officer/Asstt. Nodal officer.
- They will accompany the buses & will be responsible for to and fro journey of the farmers.
- They will inform the farmers to board the bus from the same place where they will be dropped at the summit venue & will also inform them the time of departure from the summit venue.
- They will also collect the Coupons for Lunch from the DDA (Deputy Director Agriculture) and provide the same to the farmers.
- They will make sure that they will be in constant / regular touch with the concerned Nodal Officer of HSAMB, DDA (Deputy Director Agriculture) of their respective districts & with the concerned official of the HSAMB posted at the counter of each district at summit venue.

The District-wise list of number of Buses to be arranged and provided by the concerned Deputy Director Agriculture and Farmers Welfare of each district is also enclosed for information.


