ORDER

Sh. Harish Kumar, Peon was charge sheeted under Rule-8 of the Haryana Civil Services (P&A) Rules, 1987 vide this office Memo No. C&E-III-2008/2884/34447 dated 29.04.2008 and following allegations were levelled against him:-

“That the Executive Engineer, HSAMBoard, Sonipat vide his memo no. 2206 dated 25.09.2007 has reported that he (Harish Kumar) remained willful absent from duty w.e.f. 08.06.2007 to 03.09.2007. Further vide memo No. 748 dated 14.03.2008, the Executive Engineer reported that Sh. Harish Kumar is again absent from duty w.e.f. 10.01.2008 to till date without any intimation/leave application or prior permission of the competent authority. He was directed vide memo No. 497 dated 25.02.2008 and Registered letter no.577 dated 05.03.2008 to attend his duty but he did not attend his duty till date. Thus, he is habitual of remaining absent from duty from time to time, which tantamount to misconduct on his part towards his official duties, indiscipline and violation of a instructions issued by Finance Department, Haryana vide no. 11/82/99-IFR-II dated 06.10.1999.”

“That he has violated the Rule 3(1) (ii) (iii) of the Government Employees (Conduct) Rules, 1966 and remained negligent in discharging his official duties regularly, sincerely & diligently.”

He was asked to submit reply within 15 days from the receipt of communication. However, he did not submit any reply to the charge sheet. He was called for hearing before the then Secretary Board on 02.06.2009. During hearing, it was ordered by the competent authority to put up the case after one month and to seek report from the Executive Engineer, Sonipat regarding his attendance before taking final action into the matter. Accordingly, the Executive Engineer was asked vide memo dated 04.06.2009 to send a report regarding punctuality of the official for the period from 02.06.2009 to 02.07.2009. It was reported by the Executive Engineer, HSAM Board, Sonipat that the delinquent official has not

improved his performance and punctuality regarding attendance in office, vide his memo No.2215 dated 23.07.2009.

Thereafter, the Executive Engineer, Sonipat was again requested vide this office memo dated 06.08.2010 to send a proper consolidated absence period of Sh. Harish Kumar, Peon from 08.06.2007 to till date along with joining report, if any. The Executive Engineer, HSAM Board, Sonipat vide letter dated 17.12.2010 reported that the official remained absent from duty from 10.11.2010, 15.11.2010 to 25.11.2010. The delinquent official was again afforded another opportunity of personal hearing on 17.09.2012 by the then Secretary of the Board, but he did not turn up. He was again provided an opportunity of personal hearing on 03.09.2013, by the then Secretary Board which he attended.

I have gone through the related record, charge sheet, report of Executive Engineer, HSAM Board, Sonipat regarding punctuality of the official and found that he left the office without prior permission of the competent authority as he admitted during the course of hearing. Thus, he remained negligent in discharging his official duties regularly, diligently, sincerely. Since the official is no more hence, the case against him is filed and the absence period *from 08.06.2007 to 03.09.2007 and 10.01.2008 to 14.03.2008* is treated as leave of the kind due.
