
Sh. Ved Ram son of Sh. Parbhati, Clerk (Retd.) was appointed as Peon, in the Board vide Memo No. Admn-IV-1982/23036-75 dated 02.04.1982 in the pay scale of Rs.80-3-104/4-120 plus usual allowances and he joined as such on 09.04.1982. As per rule 5(1) of the HCS (ACP) Rules, 1998, following provision has been prescribed:-

“Every Government servant who, after regular satisfactory service for a minimum period of 10 years, if the minimum period is not otherwise prescribed to be different than 10 years either in these rules or by the Government for any class or categories of Government servant from time to time, has not got any financial up-gradation in terms of grant of a pay scale higher than the functional pay scale prescribed for the post as on 31.12.1995, on which he was recruited as a direct recruited fresh entrant:-

- (a) either as a consequence of his functional promotional in the hierarchy, or
- (b) as a consequence of the revision of pay scale of the same post, or
- (c) as a consequence of any other event through which the functional pay scale of the post has been upgraded, with respect to the functional pay scale prescribed for the post as on 31.12.1995, shall for the purposes of drawn of pay, be eligible for placement into the First ACP scale with reference to him.”

From the above provision, it is clear that the ACP was to be granted with reference to the functional pay scale prescribed for the post as on 31.12.1995, on which he was recruited as a fresh entrant. But he had already been promoted and drawing pay in the promotional scale of pay and thus, this condition was not observed and he was wrongly granted ACP Scale of Rs.4000-6000 w.e.f.



01.08.2002 vide order Endst. dated 16.11.2007, contrary to the provisions of HCS (ACP) Rules, 1998.

Accordingly, he was issued a show cause notice vide memo No. Admn. IV-2017/7375 dated 13.02.2017 for withdrawal of the ACP scale of Rs.4000-6000 granted to him wrongly w.e.f. 01.08.2002 with the direction to submit his representation, if any, in writing within 21 days from the receipt of the communication. He was afforded an opportunity of personal hearing on 06.07.2017. During hearing before the then Secretary Board, he has given a statement that ~~if he has~~ wrongly been granted ACP scale of Rs.4000-6000 w.e.f. 01.08.2002 in contravention with the HCS (ACP) Rules, 1998, then he has no objection if it is withdrawn. He has also requested that his 2nd and 3rd ACP scales as admissible under the ACP Rules may be granted to him from the date of his eligibility/admissibility.

In view of above position, the 1st ACP scale of Rs.4000-6000 - w.e.f. 01.08.2002 earlier granted vide office order Endst. No. Admn. IV-2007/1729/752+5-47 dated 16.11.2007 to Sh. Ved Ram, Clerk (Retd) is hereby withdrawn.





Sh. Romesh Garg, Executive Engineer was charge sheeted under rule-7 of the HCS (P&A) Rules, 1987 vide this office memo No C&E-II/2082/2016/38106 dated 24.05.2016 and the following charges were levelled against him:-

1. That he in connivance with the Sub Divisional Engineer/Junior Engineer/Agency released the payment of sub standard work & under gauge stone metal, stone aggregates by 19.25% and caused financial loss of Rs.65,586/- to the Market Committee/Board for his ~~personal~~ gains.
2. Thus, he has failed to perform his official duties honestly, sincerely and diligently & has violated the provisions laid down under Rule 3 (III) (iv) & (xii) of Work Procedure of the Board & Haryana PWD Code, para No. 6.5.19 and 20.5.1 and PWD Manual of Orders, para No.5.4 (I) (a) and Rule 3(1) (i), (ii), (iii) & 3 (2) (ii) of the Haryana Government Employees (Conduct) Rules, 1966.

The delinquent officer submitted his reply vide letter dated 16.06.2016 and denied all the charges stating that he has joined as XEN, Sirsa on 01.05.2014 and no work of stone metal was executed/completed and paid during his tenure. An amount of Rs. 65,586/- has been recovered from the pending dues of the agency and there is no loss to the Board on this account. He also stated that baseless allegations have been leveled against him and requested to drop the ~~charges to meet the ends of justice.~~

The reply of the charged officer was placed before the Administrative Committee in its meeting held on 24.11.2016. The Administrative Committee decided that the matter may be put up in next meeting.

In the meantime, the charged officer gave a representation and requested to drop the charge sheet. The representation of the charged officer was sent to the Technical Advisor for his comments, who has offered his comments vide note dated 29.12.2016 stating that it is clear that the execution of the item of providing, laying, watering and compacting 75mm thick water bound macadam does not pertain to the incumbency of Sh. Romesh Garg. Final bill was got reviewed from CFA and final payment was made to the agency after obtaining an undertaking from the executing agency.

The representation of the charged officer alongwith comments offered by the Technical Advisor was again placed before the Administrative Committee in its meeting held on 07.11.2017 vide agenda item No.5. The

case was considered and decided by the Administrative Committee as under:-

"The committee confirmed the orders of Chief Administrator dated 24.05.2016 of issuing charge sheet under rule 2.2(b) to Madan Pal, XEN (Retd.) and under rule- 7 to Sh. Romesh Garg, XEN. The committee considered the replies of both the charged officers and comments offered by the Technical Advisor in detail and after due deliberation the charge sheet issued to Sh. Romesh Garg was dropped. In case of Sh. Madan Pal, Smt. Meenakshi Dahiya, I.O. will conduct the regular departmental enquiry and Sh. Sudesh Jindal, XEN will be the P.O."

Sh. Naresh Kumar Bansal, Executive Engineer was charge sheeted under rule-7 of the HCS (P&A) Rules, 1987 vide this office memo No C&E-II/1753/2012/42570 dated 10.07.2012 and the following charges were levelled against him:-

1. That he in connivance with S.D.E./J.E./Agency allowed sub standard work i.e. stone metal laying & consolidation of stone metal & screening and caused pecuniary loss of Rs. 45,411/- to the Market Committee/Board.
2. That he in connivance with S.D.E./J.E./Agency allowed sub standard work i.e. less consumption of bitumen and caused pecuniary loss of Rs.35000/- (on proportionate basis) to the Market Committee/ Board for his personal gains.
3. That he got released payments to the agency without carrying out any testing of samples from Govt./approved laboratory with ulterior motive.
4. That he failed to perform his official duties honestly, sincerely, diligently and violated the provisions laid down in para No. 3 (III) (iv) & (xii) of the work procedure of the board and Rule 3 (I) (ii) and (iii) & 2 (i) and (ii) of the Government Employees (Conduct) Rules,

The charged officer submitted reply to the charge sheet on 04.09.2012 and denied all the charges leveled against him.

The reply of the charged officer was placed before the Administrative Committee in its meeting held on 21.06.2013. Accordingly, the enquiry was entrusted to Sh. R.P. Bhasin, Distt. & Sessions Judge (Retd.) vide order dated 18.07.2013, who has submitted his report vide memo dated 17.01.2014 wherein he has proved all the charges levelled against him. A copy of the enquiry report was sent to him vide memo dated 28.01.2014 with the direction to submit his representation/objections, if any, within 30 days.

The charged officer submitted his objections vide letter dated 06.02.2014 stating that he is not understood how the I.O. in his report concluded that the charges levelled against him stood proved. He has also stated that I.O. is a non-technical person and that he has not gone through the record/~~measurement~~ book and did not bother to the wrong calculations made in the loss calculation sheet prepared by Sh. R.P. Sangwan, that 70.12 cum supply of stone metal in the calculation sheet is not correct and not as per entries made in the MB at RD 0 to 400 mtr. only two layers of stone metal has been shown laid at site.

Further, he has stated that it is not understood how loss has been calculated for the combined three layers resulting less use of 70.12 cum of

stone metal, whereas only two layers of stone metal shown laid at site as well as recorded/shown in the M.B. This fact is not verified by the I.O. from the MB. He has also stated that the S.E. (QC) shown 143.29 cum stone metal which is less than the quantity paid in the MB i.e. $104.09 - 70.09 = 33.99$ cum. This fact has not been verified by the I.O. Further, Sh. R.N. Kaushik, the then XEN (QC) admitted that he never consulted the MB and had not seen the record entries made in the MB at the time of calculation of loss. Further, Sh. R.P. Sangwan, S.E. (QC) has stated in the cross examination that he had not verified the facts from the record entries made in the MB and put onus on his subordinate staff who had calculated the loss without consulting the record entries made in the MB. He has also stated that there is no loss or any less consumption of stone metal of Rs.22,789/- and Rs.5617/- can't be considered as loss.

Regarding screening, he has stated that sweepage of broken rocks mixed with chipping of stone metal when mixed with stone metal, one cannot judge its presence in the consolidation. He has further stated that no sub standard work with less consumption of bitumen was allowed by him causing loss of Rs.35,000/-. Fact is that in the 7th R/bill, 20mm thick premix carpet was ~~paid by him~~ by withholding of seal coat and part rate payment was allowed @ 338/- against Rs.440/-.

He has also stated that in wake of position explained above, the conclusions and findings of the Inquiry Officer may not be considered. Only proceedings held before the Inquiry Officer may be considered. He has requested to drop the charges levelled against him. Further, he has added that before making final order, he may be given personal hearing.

The objections submitted by the charged officer was placed before the Administrative Committee in its meeting held on 09.03.2016 and it was decided that the Chief Engineer-II will check all the relevant records in the matter and put up the matter to the Administrative Committee in next meeting. The Chief Engineer-II was requested vide U.O. dated 25.03.2016 to submit his comments.

The Chief Engineer-II, submitted his comments on 30.08.2016 intimating that during the tenure of Sh. N.K. Bansal, XEN, only one layer of stone metal was laid from RD 10 to 275, 280 to 480 and 790 to 1100. The loss was calculated by assuming three layers of soling/stone metal from RD 0 to 450mtr. whereas only two layers of stone metal were laid in RD 0 to 400mtr. Whereas the inspecting Officer (QC) got checked the stone metal laid at site at four locations in a length of 2200m i.e. at RD 450m, 900m, 1400m, and 2000m. While excavated material in a standard box of size 60cm x60cm, quantity of stone metal was found 2" & 1.5" less respectively

against the required thickness of 3 layers of 4" thick each i.e. 12" less. As per findings and work done during the tenure of Sh. N.K. Bansal, EE, 57.97 cum material was found less. The detail is given below.

On the basis of above shortage of material, the loss worked out as under:-

i)	Less supply of stone metal 57.97 cum @ Rs.325/-cum=	18,840.00
ii)	Laying and consolidation of stone metal 57.97 cum@ (Rs.24.65 per cum+225% CP) minus 1% below i.e. Rs.73.91 per cum	= 4,698.00
	Total	= 23,538.00

Regarding the loss of Rs.17,464/- for use of local earth instead of screening in the consolidation of stone metal, the inspecting officer has not carried out any test and reported only on the basis that 'it seems' that without any authentic documents/report, holding somebody responsible may lead to further complications. He has also intimated that the full quantity of screening i.e. 93.39 cum costing to Rs.17,464/- was procured prior to the joining of Sh. N.K. Bansal and he can't be held responsible for any loss on account of local earth instead of screening in the consolidation of stone metal.

Regarding bitumen, alleged less consumption of 1.72 MT bitumen was arrived on the assumption that the required contents of bitumen are 4.78%. As per prevailing practice in PWD (B&R) and SVB, the bitumen contents in the premix carpet 6mm thick seal coat should not be less than 4.20%+ 0.3. In this case, bitumen contents found were 4.36%. As such, bitumen contents are found on higher side than the required parameters. The loss of Rs.35,000/- shown on account of less consumption of bitumen is not based on facts.

The loss amount on a/c of shortage of stone metal /laying and consolidation of stone metal in lieu of the work done during the tenure of Sh. N.K. Bansal is Rs.23,538/- and apportionment of this amount by considering responsibility of JE, SDE and EE in the ratio of 40:40:20, the loss amount to be recovered from him works out to Rs.4,708/-.

The objections submitted by the charged officer as well as comments offered by the of Chief Engineer-II were placed before the Administrative Committee in its meeting held on 07.11.2017 vide agenda item No.7. The case was considered and decided by the Administrative Committee as under:-

"The committee observed that the objections on the enquiry report filed by the officer were placed before the Administrative Committee in its meeting held on 09.03.2016 and it was decided that the C.E.-II will

check all the relevant record in the matter and put up the matter in its next meeting. The Committee considered the objections submitted by the charged officer as well as comments offered by the C.E-II in detail. The Committee heard Sh. N.K. Bansal, in person. The Committee observed that the charge sheet of SDE and JE involved in this case has already been decided by the Chief Administrator by awarding punishment of stoppage of one increment without cumulative effect, besides recovery of loss @ 40% each. The Committee observed that as per the report of C.E.-II dated 30.08.2016, the loss amount in lieu of the work done during the tenure of Sh. N.K. Bansal, is Rs. 23,538/- and apportionment of this amount by considering responsibility of XEN, the loss amount to be recovered from him is Rs.4,708/-. After due deliberation, the Committee decided to impose 2% cut in pension for a period of one year besides the recovery of loss amount of Rs.4,708/-".


He is informed accordingly.

ORDER**

Sh. Madan Pal, Executive Engineer was charge sheeted under rule-2.2 (b) of the Punjab Civil Services Rules, Vol. II. read with Rule 7 of the HCS (P&A) Rules, 1987 vide this office memo No C&E-II/2065/2016/53854 dated 22.07.2016 and the following charges were levelled against him:-

- 1 That he allowed/released the excess payment of bitumen and caused financial loss of Rs.32,990/- to the Market Committee/Board.
- 2 That he allowed/released the excess payment on account of substandard GSB work and caused financial loss of Rs.1,91,231/- to the Market Committee/Board.
- 3 That he in connivance with the Sub Divisional Engineer/Junior Engineer/Agency released the excess payment of sub standard work, i.e. bitumen and overgauge GSB amounting to Rs.32,990/- & Rs.1,91,231/- respectively, which comes to Rs.2,24,221/- and thus, caused financial loss to the Market Committee/ Board for his personal gains.
- 4 Thus, he has failed to perform his official duties honestly, sincerely and diligently & has violated the provisions laid down under Rule 3 (III) (iv) & (xii) of Work Procedure of the Board & Haryana PWD Code, para No. 6.5.19 and 20.5.1 and PWD Manual of Orders, para No.5.4 (I) (a) and Rule 3(1) (i), (ii), (iii) & 3 (2) (ii) of the Haryana Government Employees (Conduct) Rules, 1966.

The charged officer submitted reply to the charge sheet vide letter dated 20.10.2016 and denied all the charges leveled against him.

The reply of the charged officer was considered by the competent authority and was found unsatisfactory. Accordingly, the enquiry was entrusted to Sh. R.P. Bhasin Distt. & Sessions Judge (Retd.) vide order dated 26.10.2016, who has submitted enquiry report vide memo dated 09.01.2017, wherein he has proved all the charges leveled against him.

The enquiry report was considered by the competent authority and it was decided to send a copy of the enquiry report alongwith dissenting note to the delinquent with the directions to submit his objections/reply within 30 days. Accordingly, the same were sent to him vide memo dated 24.01.2017.

The charged officer has submitted his objections/reply vide letter dated 16.02.2017 stating that:-

- 1 That the copies of the documents produced by the department during the inquiry were not handed over to him in advance to cross examine the prosecution witnesses on the basis of produced documents. Hence, no adequate time was granted by the Inquiry Officer. The Inquiry Officer proved his connivance with SDE/JE/contractor without any documentary evidence while during his tenure, huge amount of Rs.3,59,611/- (Rs.1.06,165/- +2,53,446/-) of contractor was retained by him on account of premix carpet and security respectively.

- 2 That the IO has not considered his reply to the charge sheet and has rejected at page-11 in his enquiry report in last two lines & beginning two lines of page-12 by writing that "the evidence of delinquent when examined in totality of the facts/circumstances on record would have to be rejected being meritless and he rejected the same being unworthy of acceptance. He has admitted that the entire amount as shown in the charge sheet has been recovered from the contractual agency after the issuance of charge sheet. Thus, there was no financial loss to the HSAMBoard". During cross examination, it was stated that "the total amount of Rs.40,217/- as assessed under orders of the Technical Advisor had been recovered from the agency. During his tenure, the SDE had retained the amount of agency by making less payment of Rs.1,06,165/- on account of premix carpet and final payment and security was not released by him and it was released by his successors in the 8th and final bill.
- 3 That the I.O. did not consider actual facts and has not gone through the measurement book and agreement and proved the charges in single line without quoting any documentary evidence to support his findings. The IO has proved charge no.1 for less use of bitumen of Rs.32,990/- whereas the amount of Rs.1,06,165/- on this account was retained and he released Rs.8,73,058/- against Rs.9,79,223.00/- which works out at full rate. Similarly, in charge ~~no.2~~ on account of sub standard of GSB work of Rs.1,91,231/-, but as per record (MB page-92), only 4.90 cum GSB worth Rs.5304/- was paid during his tenure. Moreover, as per agreement conditions, upto 10% over gauge material is acceptable. Charge No.4 has also been proved without going through the relevant quoted rules as all have different meanings, agreement clause-7, departmental financial rules-7.110 and aging factor (sample were taken on 28.07.2015 & 01.10.2015 after 22 months from the date of execution of premix carpet on 19.11.2013, even than found in required limit of 3.69% & 3.86% against required 3.43%). The IO did not examine the duties of each officer assigned under B&R Manual of Orders. Hence, the enquiry report is not based on the rules. As per PWD Code-7.28 & 7.29, SDE is responsible for rates allowed by him as per quality of each item of the work but IO has proved these charges against him.
- 4 That the IO has also ignored the test reports of WAPCOS dated 05.11.2013 & Micro Lab. dated 09.11.2013 & 13.11.2014 in which bitumen contents were in order, without quoting any reason.
- 5 That the IO has proved charge no.4 without considering the contents of letter dated 04.11.2017 produced by him during the enquiry as RW1/2 and RW3. The XEN in his letter dated 04.01.2017 has made every point clear that the sample reports taken by the SE on 23.07.2015 and SDE (QC) on 01.10.2015 are contradictory, but the IO has proved the charges on the bases of these reports. He has also stated that if the matter had been considered keeping in view the above stated observations, such type of defective finding would not be there. He has requested to consider the above stated observations before final decision on the inquiry report as it suffers from infirmity, irregularities or insufficiency of evidence and personal hearing may be allowed to explain the case.

The objections submitted by the charged officer were placed before the Administrative Committee in its meeting held on 07.11.2017 vide agenda item No.09. The case was considered and decided by the Administrative Committee as under:-

"The Committee confirmed the orders of Chief Administrator of appointment of IO/PO. The Committee considered the enquiry report and objections submitted by the charged officer in detail. The Committee heard Sh. Madan Pal, in person. Further, the committee was informed that the charge sheet under rule 2.2 (b) against S/Sh. Bhoop Singh, SDE, Kashmira Singh, JE and charge sheet under rule-8 against S/Sh. Romesh Garg, XEN, Bhoop Singh Beniwal, SDE and Mam Chand, JE are still pending which are to be decided by the Chief Administrator. The committee observed that the total loss of Rs.2,24,221/- on account of over gauge GSB and less bitumen is involved in this case. However, after thorough consideration and taking a lenient view in the matter the committee decided to award the punishment of censure to Sh. Madan Pal, XEN, besides 10% recovery of total loss of Rs.2,24,221/-".

He is informed accordingly.

Sh. Madan Pal, Executive Engineer was charge sheeted under rule-12 (2) (b) of the Haryana Civil Services Rules, 2016 read with Rule-7 of the HCS (P&A) Rules, 2016 vide this office memo No C&E-II/2093/2016/73540 dated 05.10.2016 and the following charges were levelled against him:-

1. That he allowed/released the payment of interlocking paver blocks having compressive strength of 30.0, 31.1, 29.9, 31.3, 33.0 N/mm² with an average of 31.6N/mm², 27.5, 28.1, 25.6, 25.2, 28.9, 30.9 N/mm² with an average of 27.06N/mm² and 28.0, 31.6, 30.9, 29.3, 34.5 N/mm² with an average of 30.86N/mm². The total average is $(31.06+27.06+30.86)/3= 29.66\text{N/mm}^2$ against the minimum requirement of 35N/mm², hence it is inferior than the required compressive strength and thus, he has caused financial loss of Rs.1,01,673.91 to the Market Committee/Board.
2. That he in connivance with the Sub Divisional Engineer/Junior Engineer/Agency released the payment of sub standard work, i.e. inter- locking paver blocks material and caused financial loss to the Market Committee/ Board for his personal gains.
3. Thus, he has failed to perform his official duties honestly, sincerely and diligently & has violated the provisions laid down under Rule 3 (III) (iv) & (xii) of Work Procedure of the Board & Haryana PWD Code, para No. 6.5.19 and 20.5.1 and PWD Manual of Orders, para No.5.4 (I) (a) and Rule 4(1) (i), (ii), (iii), (iv) and 4(2) (ii) of the Haryana Government Employees Conduct Rules, 2016.

The charged officer submitted reply to the charge sheet vide letter dated 18.11.2016 and denied all the charges leveled against him.

The reply of the charged officer was considered by the competent authority and was found unsatisfactory. The enquiry was entrusted to Sh. R.P. Bhasin, Distt. & Sessions Judge (Retd.) vide order dated 22.02.2017, who submitted his report vide memo dated 25.04.2017, wherein he has proved all the charges leveled against him.

The enquiry report was considered by the competent authority and a copy of enquiry report was sent to him vide memo dated 11.05.2017 with the direction to submit his objections/reply within 30 days positively.

The charged officer has submitted his objections vide letter dated 08.06.2017 and denied all the charges/allegations leveled against him stating that :-

1. The enquiry officer has not quoted any legal evidence/document to arrive at his conclusion to prove the charges against him. Thus, the IO's report is totally based on assumptions and suspicion. The Measurement Book was produced but the same was not examined by the IO because he was not well conversant with the technical matters and agreement clauses executed with the concerned contractor to execute and complete the work. The enquiry report is not based on documentary evidence and statement of witnesses cross examined during the enquiry.

- 2 The IO was not expert in the technical matter, which was essentially required as per Rule to conduct the enquiry related to a technical matter as his appointment was challenged by the charged officer vide memo dated 21.03.2017.
- 3 The finding of the IO was not charge-wise as required under the rules. The IO has quoted irrelevant story at page-7 to 10 to make the enquiry lengthy only to divert the mind of the competent authority to arrive at actual conclusion.
- 4 The IO has rejected the plea/documents submitted by charged officer in a single line at page-12 of the enquiry report without quoting any documentary evidence. During enquiry, he had ordered verbally to charged officer on the last date of hearing to submit the written brief without handing over a copy of written brief to be submitted by the PO and without calling the lab official as witness to give the answer of question no.10 asked by him. However, as per rules and principles of natural justice, above stated/demanded documents had to be given to the charged officer and essential witness had to be called by the IO before demanding brief from the charged officer but in this case it was not complied.
- 5 During the cross examination of PW1 (Sh. Suresh Pal Saini S.D., SVB (H)) failed to point out the area of interlocking paver blocks executed during his tenure. Further, he had also failed to point out the locations of work at which samples were taken and also failed to submit the instructions regarding post construction testing of samples as in the instant case samples were tested after laying the paver blocks.
- 6 During cross examination, the PW1 had admitted in answer to question no.6 ,7 and 12 that as per IS Code 15658-2006, 8 no. paver blocks were required to be tested on one sample but in this case, 5 no. paver blocks were taken to be tested in one sample. Thus, the mode of sampling was not as per prescribed Rules as explained under point no. 9.
- 7 During cross examination, the PW-I had admitted in answer to question no. 9 that paver blocks were inspected on 07.01.2015 but he deliberately not intimated the date of execution of work in question. As per record in MB no.15257 (page-42 & 60=61), execution date was 04.10.2013.
- 8 During the cross examination, the PW1 had not replied to question no.10, the reply to which was essential to bring out the truth as passage of time and climate etc. reduced the compressive strength of paver blocks as prescribed in the accepted rules IS 15658:2006. The compressive strength was found 30.86N/mm² against the requirement of 30.31N/mm² after lapse of 14 months. Therefore, the witness of lab was essentially required in this case. If it was not possible to call him as witness, the provisions mentioned in the accepted rules-IS 15658-2006 at 8.6 ,0.1.4 and notes-2 had to be taken into account to determine the compressive strength of paver blocks. During cross examination, the witness no.2 admitted in ans. to Q no.3 that the samples were taken with the help of Hammers, Chisel & Pick-Ase. Hence this admission proves that damages were occurred to paver blocks during dismantalling carried out before testing the samples which effected the results.
- 9 During the cross examination, the prosecution witness-2 had accepted in answer to question no.9 that condition of paver block was satisfactory and no paver block was changed in annual repair. He had also accepted in reply to question no.11 that there is no loss to department.

Charge No.1, he has stated that how the I.O. had proved the alleged loss when prosecution witnesses-2 had admitted in reply to question no.11 that there is no loss to the department.

Charge No.2, he has stated that how the I.O. has proved the work of sub standard quantity when prosecution witness No.1 has accepted in reply to question no. 6, 7 & 12 that as per IS 15658:2006, 8 no. paver blocks were required to be tested in one no. sample before laying the paver blocks but in the instant case 5 no. paver blocks were taken and tested in one sample after laying the blocks and after lapse of 14 months from the date of its laying. Hence, the mode of testing of the sample was not as per required norms.

Charge No.3, is not an independent charge, so no specific reply is required. He has stated that the charge sheet is vague in itself because it does not disclose how much of the loss is attributable to each employee out of total alleged loss mentioned in the charge sheet.

The objections submitted by the charged officer were placed before the Administrative Committee in its meeting held on 07.11.2017 vide agenda item No.06. The case was considered and decided by the Administrative Committee as under:-

"The Committee confirmed the orders of Chief Administrator of ~~appointment~~ of IO/PO. The Committee considered the enquiry report and objections submitted by the charged officer in detail. Sh. Madan Pal, (Retd.) was heard in person. Further, the Committee observed that the charge sheets of SDEs and JE involved in this case have already been decided by the Chief Administrator and they were warned to be careful in future, as the recovery pointed out by the SVB (H) Rs.1,01,674/- has been made good from the agency. Thus, taking a lenient view being retiree, the committee decided to award the punishment of Censure to Sh. Madan Pal, XEN (Retd.).

He is informed accordingly.
