

Sh. Jawahar Lal, SDC, HSAM Board, Panchkula was appointed as Peon on transfer basis in the Board vide Memo No. Admn-II-1993/62388-91 dated 29.09.1993 in the pay scale of Rs.750-12-870-EB-14-940+30SP plus usual allowances and he joined as such on 01.10.1993. He was further promoted to the post of Clerk in the pay scale of Rs.950-20-1150-EB-25-1500+Rs.40 S.P. vide order Endst. No. Admn-IV-95/1105/71491-514 dated 27.11.1995 and he joined as such on 27.11.1995 (F.N.).

He was granted first ACP Scale of Rs.4000-6000 w.e.f. 01.12.2005 vide order Endst. No. Admn-IV-2007/49123-24 dated 16.07.2007. The Haryana Civil Services (Assured Career Progression) Rules, 1998 were notified by the Haryana Govt. vide Notification No. GSR 4/Const./Art 309/98 dated 7.1.1998, effective from 01.01.1996. As per rule 5(1) of the HCS (ACP) Rules, 1998, following provision has been prescribed:-

“Every Government servant who, after regular satisfactory service for a minimum period of 10 years, if the minimum period is not otherwise prescribed to be different than 10 years either in these rules or by the Government for any class or categories of Government servant from time to time, has not got any financial up-gradation in terms of grant of a pay scale higher than the functional pay scale prescribed for the post as on 31.12.1995, on which he was recruited as a direct recruited fresh entrant:-

- (a) either as a consequence of his functional promotional in the hierarchy, or
- (b) as a consequence of the revision of pay scale of the same post, or
- (c) as a consequence of any other event through which the functional pay scale of the post has been upgraded, with respect to the functional pay scale prescribed for the post as on 31.12.1995, shall for the purposes of drawn of pay, be eligible for placement into the First ACP scale with reference to him.”

From the above provision, it is clear that the ACP scale was to be granted with reference to the functional pay scale prescribed for the post as on 31.12.1995, on which he was recruited as a fresh entrant. But he had already been promoted and drawing pay in the promotional scale of pay and thus, this

condition was not observed and he was wrongly granted ACP scale of Rs.4000-6000 w.e.f. 01.12.2005 vide order Endst. dated 16.07.2007, contrary to the provisions of HCS (ACP) Rules, 1998.

Accordingly, he was issued a show cause notice vide memo No.Admn.IV-2018/20545 dated 11.04.2018 for withdrawal of the ACP scale of Rs.4000-6000 granted to him wrongly w.e.f. 01.12.2005 with the direction to submit his representation, if any, in writing within 21 days from the receipt of the communication. He submitted his reply vide letter dated 25.06.2018 giving his consent that if he was granted the 1st ACP scale wrongly, the same may be withdrawn and his pay may be re-fixed as per applicable Rules/instructions.

Thereafter, he was afforded an opportunity of personal hearing on 12.07.2018. During hearing also, he has again stated that if he has wrongly been granted ACP scale of Rs.4000-6000 w.e.f. 01.12.2005 in contravention with the HCS (ACP) Rules, 1998, then he has no objection if it is withdrawn. He has also requested that his ACP scale as admissible under the ACP Rules may be granted to him from the date of his eligibility/admissibility.

In view of above position, the Ist ACP scale of Rs.4000-6000/- w.e.f. 01.12.2005 earlier granted vide office order Endst. No.Admn-IV-2007/49123-24 dated 16.07.2007 to Sh. Jawahar Lal, SDC is hereby withdrawn.







ORDER

Shri Romesh Garg, Executive Engineer was issued charge sheet under **Rule 8** of the Haryana Civil Services (Punishment & Appeals) Rules, 1987 vide this office Memo No.C&E-II-2065/2016/53857 dated **22.07.2016** with following allegations:-

"That the administrative approval for the work 'construction of road from Moriwala Highway No.10 to village Kotli in Sirsa Division)' was accorded by the competent authority for Rs.58,84,600/- vide letter dated 28.08.2012. The work was allotted to Sh. Jimmi Kumar, Contractor vide letter dated 27.11.2012 by the Executive Engineer, HSAMBoard, Sirsa. The agreement was executed between the Executive Engineer and the contractual agency.

The following provisions were approved as per scope of the work:

- 1 Earth work from a lead of 2 KM including watering & rolling.
- 2 150mm thick GSB, G-III, as per MORD specifications.
- 3 2 layers of stone metal 75mm thick each.
- 4 20mm thick premix carpet including priming coat with emulsion, tack coat & B-type seal coat.

That the work of laying of premix carpet with seal coat was executed at site on 19.11.2013. During the intervening period, but well before the execution of premix carpet with seal coat, instructions were issued by the Board vide memo No. Executive Engineer (QC)-2013/205-238 dated 16.08.2013 wherein the quantities of seal coat were reduced to 2/3 i.e. using bitumen @ 45.3 kg/100 sqm & sand @ 0.40 cum/100 sqm against the earlier approved provision of 68 kg/100 sqm and @ 0.60 cum/100 sqm respectively and the rates were asked to be adjusted accordingly.

That the work was got executed under the supervision of his predecessor, but the enhanced payment for the work of the seal coat as well as final payment for the whole work was released by him. The work was inspected by the Superintending Engineer, HSAMBoard, Hisar on 28.07.2015 alongwith S/Sh. Ashok Singh Nain, Sub Divisional Engineer (QC) in the presence of Sh. Bhoop Singh, Sub Divisional Engineer in-charge of the work. The work stood already completed and finalized. The samples of premix carpet including tack & seal coat were collected from the site from RD 620, 1320 and 1794 mtr. and got tested in the departmental lab at Hisar. As per test results, the bitumen contents were found 3.58%, 3.44% & 4.05% respectively (average 3.69%) against the requirement of 4.03%. As such, the execution of work was not found satisfying the requirement of revised specifications approved by the Board.

The work was again checked by the Sub Divisional Engineer (QC), Rohtak alongwith S/Sh. Naresh Kumar, ASDE, Surender Gupta, Junior Engineer (QC) HSAMBoard, Rohtak and Mohan Lal, Junior Engineer, HSAMBoard, Sirsa on 01.10.2015. Three no. samples of premix carpet at RD 600m, 1400m & 1450m and two no. samples of GSB material at RD 600m & 1400m were taken and got tested in the lab of Sirsa Division. As per test results of sieve analysis for grading of GSB, the material was found over gauge to the tune of 7.89% and 9.25% respectively on sieve 26.5mm i.e. average 8.57%. Shortage of material in GSB was also found to the tune of 11.57%. As per test results of premix carpet with seal coat, the bitumen contents were found 3.56%, 3.61% & 4.40%, average 3.86% against the requirement of 4.20%. As such, the gradation of GSB material and bitumen contents in the premix carpet were not found as per requirement of the specifications of DNIT and the instructions issued by Board vide memo No. 205-238 dated 16.08.2013.

During scrutiny of the relevant Measurement Book No.13716, it has been found that the item of seal coat was executed and paid through 6th running bill for the work @ Rs.26/- per sqm i.e. 2/3 of Rs.40.79 per sqm, as per

- 2 -

instructions dated 16.08.2013 by his predecessor. The consumption statement for the bitumen also stands prepared accordingly in the MB at page No. 86 for 6555.06 Sqm @ 2.16 Kg/Sqm = 14.16 MT.

Sh. Romesh Garg, Executive Engineer, with ulterior motive and in illegal connivance with the Junior Engineer, Sub Divisional Engineer and Contractual agency, has increased the rate of seal coat item which although stood already executed and paid through his predecessor in the 6th running bill and the same has been found below specifications as per the test results referred above. The rate of premix carpet was increased from Rs.105/- per sqm. to Rs. 106.14 per Sqm. & the rate of seal coat from Rs.26/- per Sqm to Rs. 40.79/- per Sqm for the whole quantity of 6664.56 Sqm thereby resulting in release of excess payment to the contractual agency, causing financial loss to the department to the tune of Rs.1,06,166/- (6664.56 Sqm @ Rs. 15.93/- Sqm.). This act of making fraudulent payment by him is proved/ authenticated by the receipt as well as consumption statement of bitumen prepared in the concerned MB at page No. 140 wherein it has been worked out as 6664.56 sqm @ 2.16 Kg/Sqm = 14.40 MT. As such, the rate of bitumen consumption i.e. 2.16kg/sqm, considered in the consumption statement prepared in the 8th & final bill at page No. 140, is the same as was there in the 6th running bill at page No. 86 i.e. @ 2.16 Kg/per Sqm, which indicates that there was neither any receipt of bitumen nor was any increase in the bitumen contents after the payment of 6th running bill. The payment for the seal coat has, however, only been got released by him malafidely @ Rs. 40.79/- per Sqm, for which the receipt as well as consumption of bitumen was required @ 2.39 Kg/ per Sqm & not 2.16kg/sqm as in the present case. A patent error has thus been committed by him whereby he has increased only the rate of item of seal coat in the final bill but has unfortunately missed to increase the quantity of receipt/consumption of bitumen required for the same purpose thereby justifying the increase in rate, which would have otherwise also been in violation of the instructions issued by the Board.

In addition to above, Shri Romesh Garg, Executive Engineer has also allowed release of excess payment for the item of GSB amounting to Rs. 1,91,231/- and less bitumen contents in premix carpet amounting to Rs. 32,990/-, the work which had already been executed & paid during the tenure of his predecessor, at the time of making payment of final bill to the contractual agency. It has resulted in the release of total excess payment of Rs.3,30,387/- to the contractual agency as per details given below:-

- 1 The excess payment on account of deficiency in GSB amounting to Rs.1,91,231/- and use of less quantity of bitumen amounting to Rs.32,990/-, total Rs.2,24,221/-. The work was already got executed & paid during the tenure of his predecessor, but he allowed the said excess payment.
- 2 The excess payment on account of undesirable increase in the rate of seal coat amounting to Rs.1,06,166/-. Thus, he released excess payment and caused financial loss of Rs.3,30,387/- to the Market Committee/Board.

That he in connivance with the Junior Engineer/Sub Divisional Engineer and the contractual agency accepted/ allowed execution of sub standard work and released excess payment of Rs.3,30,387/- on account of overgauge GSB and less bitumen contents and also failed to ensure proper control over the work.

Thus, he has failed to perform his official duties honestly, sincerely and diligently & has violated the provisions laid down under Rule 3 (III) (iv) & (xii) of the Work Procedure of the Board & Haryana PWD Code, para No. 6.5.19 & 20.5.1 and PWD Manual of Orders para No.5.4 (I) (a) and Rule 3(1) (i), (ii), (iii) & 3 (2) (ii) of the Haryana Government Employees (Conduct) Rules, 1966".

He was asked to submit reply to the charge sheet within 15 days from the receipt of memorandum. The delinquent officer submitted reply to the charge sheet vide letter dated 03.10.2016 and denied all the allegations stating that the work was

completed on 28.11.2013 wherein the work of premix carpet with seal coat was executed, completed and paid on 23.11.2013 and 28.11.2013 during the tenure of Sh. Madan Pal, Executive Engineer who retired on 30.04.2014. He joined on 01.05.2014 and no work of premix carpet and seal coat was executed during his tenure. It is a matter of record that the Junior Engineer and Sub Divisional Engineer prepared the final bill and submitted in the Division office for final payment. The record entry as well as abstract cost of 6th and 7th R/bill shows that the work was executed as per DNIT and rates of seal coat in the approved DNIT was Rs.40.79 per sqm. The bill was scrutinized by Accounts Branch as per record entries, abstract of cost and approved rate of seal coat in the DNIT/detailed estimate. Accordingly, the payment was released.


Regarding GSB, he has stated that the 5th R/bill was paid during his tenure in which payment of GSB was released at the part rate of Rs.1085 per cum, after full satisfaction regarding work done of GSB, whereas his predecessor released the payment of GSB at the full rate in the 7th R/bill. Therefore, the allegation of releasing excess payment of GSB is baseless and denied. He has stated that the work was checked by the Technical Advisor on 03.02.2016 after a gap of 2 years and 3 months after its completion wherein the bitumen contents were found within permissible limit. The grading was found overgauge by 5.62% which is within the permissible limit i.e. variation upto 10% is acceptable as per contract agreement subject to recovery of 10% of the basic rate of material and accordingly, recovery of Rs.40,217/- has been recovered from the pending dues of the agency and requested to drop the allegations.

After considering his reply, an opportunity of personal hearing was afforded to him on 14.08.2018. During hearing, he reiterated the same version as he stated in his reply to the charge sheet. He also stated that he has already retired from the service of the Board and requested to consider his case sympathetically.

After hearing the arguments and perusing the relevant record of the case, I have come to the conclusion that overgauge material was used at site and payment for sub standard work was released by the delinquent. The delinquent has himself admitted execution of work with overgauge material. It is a matter of record that he never objected execution of sub-standard work, if any, executed during the tenure of his predecessor, as per rules. Moreover, he allowed full rates in the final bill, whereas his predecessor made part payments on reduced rates, excess payment and therefore, the allegation of payment of sub standard work is clearly establishment against him. Therefore, the allegations are proved against him beyond doubt and he has been responsible for causing the said loss of Rs.2,24,221/- on account of overgauge GSB and use of less bitumen. However, taking a lenient view in the matter, he is awarded punishment of 20% recovery of the total loss of Rs.2,24,221/- on proportionate basis.




