Sh. Bijender Singh, Ad. Officer (Retd.) (CDC) H.S.A.M. Board, Panchkula was charge sheeted under Rule-2.2(b) of CSR Vol-I, Part-I read with Rule-7 of the Haryana Civil Services (Punishment & Appeal) Rules, 1987 vide memo No. C&I-4-1189/2015/115542 dated 09.12.2015 and the following charges were leveled against him:-

1. That he has misused his official position and directly submitted the case to the authorities on misleading grounds and recommended regularization of the officials who were engaged through contractual agencies without getting it examined from the concerned dealing Assistant, to give undue benefit of regularization to the contractual employees with ulterior motive.
2. That he has also failed to explain his position to the explanation call dated 25.06.2015.
3. That his act was totally unbecoming, unlawful and negligent and thus, he has acted in an unprofessional and irresponsible manner.
4. Thus, he has violated rule 3(1) (i), (ii) and (iii) of the Haryana Government Employees (Conduct) Rules, 1966 and has failed to discharge his official duties honestly, sincerely & diligently.

On receiving and considering his reply vide letter dated 04.01.2016 to the charge sheet, departmental enquiry was entrusted to Sh. M.K. Midha, IAS (Retd.) vide memo dated 19.01.2016, who submitted his findings vide letter dated 19.02.2016 proving all the charges against the delinquent officer. Accordingly, a memorandum dated 21.03.2016 along with a copy of the enquiry report was referred to the delinquent to submit his representation/objections within 30 days from the date of issue of said communication.

The delinquent submitted his reply/objections to the memorandum vide letter dated 03.04.2016, received on 08.04.2016, and denied all the charges leveled against him stating that the I.O. has failed to deal with the submissions properly and he recorded only the statement of the applicant. Thereafter Sh. Ram Singh, Dealing Assistant produced the record of the case. No other prosecution witness was examined in support of the charges against the applicant. The I.O. has obviously acted with a closed and pre-determined mind which shows that he was under undue influence and pressure of the department. The delinquent mentioned that he dealt with the file under the verbal instructions of the then Secretary Board and put up the file before him and he never objected as to why the delinquent had directly dealt with the file and that why it was not got processed from the Dealing Assistant, because the Secretary Board himself had verbally directed to the delinquent to do so. The then Secretary Board never recorded any objection on the file as to why the delinquent had not got the case processed through the Dealing Assistant. Further, no wrong or injury was caused to

the interest of the department because the case remained under process till his retirement and no final decision had been taken in this regard.

The case was placed before the Administrative Committee for decision in its meeting held on 24.11.2016 vide agenda item no. 10. He was also afforded an opportunity of personal hearing for presenting his defence before the Administrative Committee.

This case was considered and decided by the Administrative Committee as under:-

"The committee discussed the matter at length and observed that the charges/allegations are established against the delinquent by the I.O. and observed that he failed to see through that the delinquent official dealt with the case single handedly presumably. Ideally this case should have been dealt as per the procedure and protocol prescribed for such purpose. He failed to examine the case thoroughly keeping in view the policy, instructions there on precedence, judicial verdict if any. The committee feels that he is guilty of the charges incorporated in the charge sheet. Thus, he cannot go scot free in this case. However, taking a lenient view the committee decided to award him a punishment of "cut of 2% in pension for one year".

He is informed accordingly.



Sh. R.C. Deshwal, Executive Engineer was charge sheeted under rule-7 of the HCS (P&A) Rules, 1987 vide this office memo No C&E-II/2008/2015/72273 dated 27.07.2015 and the following charges were levelled against him:-

1. That he in connivance with the Sub Divisional Engineer/Junior Engineer/Agency allowed sub standard work, used less material amounting Rs.7,46,325/- and caused financial loss to the MC/Board for his personal gains.
2. That he released the payment of overgauge material as well as excess payment of work without executing the same at site of work.
3. That the thickness of stone material i.e. WBM layer was found on lesser side 105.50mm against the required thickness of 150mm.
4. Thus, he has failed to perform his official duties honestly, sincerely and diligently & has violated the provisions laid down under Rule 3(III) (iv) & (xii) of the Work Procedure of the Board & Haryana PWD Code, para No. 20.5.1, PWD Manual of Orders Rule 5.4 and Rule 3(1) (i), (ii), (iii) & 3 (2) (ii) of the Haryana Government Employees (Conduct) Rules, 1966.

The delinquent officer submitted his reply vide letter dated 15.12.2015 and denied all the charges/allegations leveled against him stating that on the direction of the EIC, the subjected work was inspected by Sh. Kudrat Singh, SDE (QC), Jind on 28.04.2015, who submitted report on 26.02.2015 wherein he pointed out that the GSB material at RD 107 & 600 mtr. was not laid. The thickness of WBM layer was also found on lesser side i.e. from 100mm to 111mm against the provision of 150mm. The stone metal was found over gauge by 19.3% and 11.74% on sieve 63mm & 53mm respectively. He has also stated that the said road was being used as a short cut route to reach Sohna Faridabad Ballbagarh road and there was also heavy loaded traffic/trucks passing through this road to avoid Toll Tax barrier situated on Sohna-Faridbad- Ballabgarh road.

After the earth work and GSB was completed, the farmers got the work stopped and demanded for demarcation. As per demand of the farmers, the demarcation was got done from the revenue department and it was found that the alignment of the road is changed. The earth work & GSB had been shifted due to change of alignment. The GSB was mixed with earth & disturbed the actual location at some places. He has further stated that there was also a deep open drain alongwith Katcha path where road was shifted in some length. Further, the EIC issued the orders to S.E, Gurgaon for rechecking of road vide Email dated 20.03.15 but the same has not been done so far. Moreover, the road is in good condition now also and solves the

required purpose for which it has been constructed. The vehicles are running smoothly. He has also requested that the road may be get checked by a senior officer.

After considering his reply, the departmental enquiry was entrusted to Shri V.P. Batra, IAS (Retd.) 09.03.2016, who submitted his enquiry report vide letter dated 26.10.2016 wherein none of the charges were proved against the delinquent officer.

The case was placed before the Administrative Committee in its meeting held on 24.11.2016 vide supplementary agenda item No 2. The case was considered and decided by the Administrative Committee as under:-

"The Committee discussed the matter at length and observed that the delinquent officer released the payment on the basis of certificate given by the JE /SDE in the Measurement Book and as per PWD Code para 20.4.16, the JE and SDE are equally responsible for quality of works upto Rs. 25.00 Lacs being minor work.

Moreover, none of the charges have been proved by the I.O. against him. Thus, the committee decided to file the matter against him with a warning to be more careful in future. The matter against JE/SDE will be decided by the Chief Administrator being competent".

He is informed accordingly.



**“Learned counsel for the petitioners submits that at this stage, he would be satisfied if the present writ petition is disposed of with a direction to respondent No.2 to take a decision on the representations dated 03.09.2015 and 10.06.2015 (Annexure P-5 and P-6 respectively, submitted by the petitioners.**

**Accordingly, without commenting on the merits of the case, the present writ petition is disposed of with a direction to respondent No.2 to take a decision on the representation dated 03.09.2015 and 10.06.2015 (Annexures P-5 and P-6 respectively), submitted by the petitioners, by passing a speaking order and after affording opportunity of hearing to the petitioners, preferably within four months from the date of receipt of a certified copy of this order.”**

In their representations, the petitioners have requested that their pay be stepped up at par with Shri Harikesh, M.S. as per Haryana Government instructions No. 22/132/2008-1GS-III dated 20.02.2013 and Hon'ble Punjab & Haryana High Court decision dated 07.08.2012 in CWP No. 17280/2011.

The matter has been examined by the office. Both the petitioners, namely S/Shri Gulab Singh S/o Shri Jhanda Ram and Jai Singh S/o Shri Dauli Ram were appointed as Clerk/Auction Recorder/Care-Taker/Arrival Recorder in the pay scale of Rs.400-10-490/540-15-600-EB-20-660 vide letter No. Ad.II-83/2924-26 dated 11.01.1983 & No.Ad-I-84/62937-41 dated 17.10.1984 and they joined as such on 12.01.1983 & 18.10.1984 respectively. Whereas Shri Harikesh who belongs to Scheduled Caste category was appointed as Clerk on 18.10.1984 & he joined as such on 20.10.1984. Shri Harikesh was further promoted to the post of Mandi Supervisor-cum-Fee Collector vide order dated 03.04.1998 in the pay scale of Rs.5000-150-7100-EB-150-7850 by giving the benefit of reservation of Scheduled Caste on the roster point. As per the final seniority list dated 31.03.2009 of Auction Recorders/Arrival Recorders/Care Takers/Store Keepers, the name of Shri Harikesh of S.C. category figures at Sr.No. 250 whereas the name of S/Shri Gulab Singh & Jai Singh figure at Sr.No. 142 & 218 respectively. After that, both were promoted to the post of Mandi Supervisor-cum-Fee Collector in the pay scale of Rs.5000-150-7100-EB-150-7850 vide order endst. No. Admn.V-2006/1542/84158-235 dated 19.10.2006 &

No. Admn.V-2009/205/12113-89 dated 20.02.2009 and they joined as such on 20.10.2006 & 20.02.2009 respectively.

A Committee was constituted by the competent authority for examining the "Stepping up cases" pending in the Board. The Committee gave its report on 08.07.2015 & 05.11.2015. As per their recommendation, the claim of S/Shri Gulab Singh & Jai Singh for the benefit of stepping up of pay w.e.f. 03.04.1998 has been considered and the benefit was allowed to them vide orders issued vide endst. No. Admn.II-2016/833/41497-99 dated 01.06.2016 & No. Admn.II-2016/912/43633-35 dated 13.06.2016. Accordingly, their pay has also been refixed vide order endst. 
