Sh. Krishan Kumar Rathee, the then Junior Engineer was charge sheeted under Rule-7 of the Haryana Civil Services (Punishment and Appeal) Rules, 1987 vide this office memo No C&E-II/2100/2017/27755 dated 27.04.2017 and the following charges were levelled against him:-

- 1 That he has entered/recommended the payment of GSB-III which was found under gauge on sieve 26.5mm & 4.75mm to the tune of 13.09% & 18.90% respectively and caused financial loss of Rs.5,12,234/- to the Market Committee/Board.
- 2 That he has entered/recommended the payment of GSB-VI which was found over gauge on sieve 9.5mm to the tune of 5.93% and on sieve 2.36mm & 0.425mm to the tune of 13.68% & 18.51% respectively and caused financial loss of Rs.1,55,977/- to the Market Committee/Board.
- 3 That he has entered/recommended the payment of WBM material which was found under gauge on sieve 22.4mm to the tune of 21.48% and caused financial loss of Rs.1,71,211/- to the Market Committee/Board.
- 4 That he in connivance with the Executive Engineer/Sub Divisional Engineer/Agency released the payment of sub standard work, i.e. GSB-III, VI and WBM material and caused total financial loss of Rs.8,39,423/- i.e. (Rs.5,12,234 +Rs.1,55,977 +Rs.1,71,211) to the Market Committee/Board.
- 5 Thus, he has failed to perform his official duties honestly, sincerely and diligently & has violated the provisions laid down under Rule 3(I) (iv), (viii) & (ix) of the Work Procedure of the Board & Haryana PWD Code, para No. 20.5.1, PWD Manual of Orders, para 5.6. and Rule 4(1) (i), (ii), (iii), (iv) and 4(2) (ii) of the Haryana Civil Services (Government Employees' Conduct) Rules, 2016.

The enquiry was entrusted to Sh. R.P. Bhasin, Distt. & Sessions Judge (Retd.), vide order dated 28.06.2017, who submitted enquiry report vide letter dated 05.09.2017 wherein he proved all the charges leveled against him.

A copy of the enquiry report was sent to the charged officer vide memo dated 01.01.2018 with the directions to submit his objections/reply within 30 days.



The charged officer submitted objections vide letter dated 25.01.2018. An opportunity of personal hearing was also given to the charged officers.

The charged official denied all the charges leveled against him. He submitted that in final bill, the rates were reduced from Rs. 916/cm to 688/cm of GSB - III which was found under gauge on sieve 26.5mm and 4.75mm totune of 13.09% and 18% and had caused financial loss of Rs. 5,12,234 and therefore, no loss has been caused to the Marketing Board. He also submitted that in the final bill, the rates were reduced from Rs. 868.81/cum to Rs. 806/cum of GSB- VI which was found under gauge of sieve 9.5mm to the tune of 5.93% and on the sieve 2.36mm and 0.425mm to the tune of 13.68%, 18.51% respectively and had caused financial loss of Rs. 1,55,977 and therefore, no loss has been caused to the Marketing Board. He also submitted that in the final bill, the rates were reduced from Rs. 1266/cum to Rs. 1184/cum of WBM material which was found under gauge on sieve 22.4mm to the tune of 21.48% and had caused financial loss of Rs. 1,71,211 /- to the Marketing Board and therefore, no loss has been caused to the Marketing Board on this account also. He also submitted that as per PWD code 20.5.3, the decision of S.E. regarding the reduction as well as Justification of rates for sub-standard work shall be final and shall not be subject of dispute or arbitration. He submitted that on account of these shortcomings a recovery of Rs. 6,80,943/- vide Memo No. 1373-74 Dated 22.05.2017 has been made from the Agency and there is no Financial loss to the Board. He also stated that the charge sheet issued to him may be withdrawn, since in several cases this procedure has been adopted. He stated that it has been alleged in charge sheet that while he was posted as SDO at HSAMB, Hisar 04.12.2004 to 28.04.2015 but he was not the in-charge of road on 04.12.2004 as the road work was not allotted on 04.12.2004. 





Shri Hans Raj was appointed as Clerk in the Haryana State Agricultural Marketing Board vide letter No. Admn.II-84/68109-12 dated 09.11.1984 and joined on 19.11.1984 in the pay scale of Rs.400-600. A request dated nil was received from him on 29.08.1991 for change of cadre from Board's cadre to Market Committee Cadre, he was asked vide letter No. 73421 dated 11.10.1991 to give an undertaking and get it forwarded through the Zonal Marketing Enforcement Officer, Haryana State Agricultural Marketing Board, Hisar to the effect that he will loose his service and seniority rendered in the Board's cadre and he was also informed that he can be offered the post of Clerk subject to availability of vacancy. Accordingly, he tendered his undertaking to the effect that his cadre may be changed from Board's cadre to Market Committee cadre. Accordingly, his cadre was changed and he was posted as Clerk in Market Committee, Bhattu Kalan vide order No. Admn.II-92/541/50138-45 dated 27.07.1992. It was clearly stipulated in the said order that his appointment in the Market Committee cadre will be treated as fresh appointment and he will not claim any benefit of seniority on account of service rendered in the Board's cadre. However, the benefit for pay protection was allowed. Therefore, his appointment in the Market Committee cadre was a fresh appointment and no seniority benefit on account of his service as Clerk in the Board cadre was admissible and he was entitled only for the benefit of pay fixation. He was also granted 1<sup>st</sup> HSS of Rs.1200-2040 vide letter No. Admn.VI-96/788/49509-41 dated 10.07.1996 w.e.f. 01.04.1995 and 2<sup>nd</sup> ACP of Rs.5000-7850 vide order dated 09.03.2006 w.e.f. 01.12.2004 as per ACP Rules, 1986. However, while considering the case for promotion to the post of Mandi Supervisor, the Board inadvertently gave the benefit of seniority w.e.f. 1984 i.e. the date of his appointment as Clerk in the Board's cadre and promoted him wrongly whereas his seniority was countable w.e.f. the date of his joining as Clerk in the Market Committee, Bhattu Kalan. Therefore, his promotion as Mandi Supervisor given vide letter No. Admn.II-2009/4339/116377-427 dated 10.11.2009 is illegal and is liable to be withdrawn.

Accordingly, a show cause notice for withdrawing his promotion to the post of Mandi Supervisor vide order No. Admn.II-2009/4339/116377-427 dated 10.11.2009, was issued vide memo No. Admn.II-2017/41931 dated 30.06.2017. He was offered an opportunity of show cause as to why the proposed action may not be taken and was asked to submit his reply within a fortnight, failing which no other opportunity of show cause will be granted and action will be taken accordingly.

He submitted his reply dated 12.07.2017 to the show cause stating that he has not requested for promotion and also requested vide letter dated 23.01.2014 that no financial benefit has been granted to him on promotion, rather the special pay of Rs.100/- on the post of Auction Recorder has been



reduced. Hence, he is not at fault in his promotion and also requested that the benefit of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> ACP may be sanctioned.

Before taking final decision on the matter, he has been given opportunity for personal hearing on 25.07.2018. During the course of personal hearing, he has taken same plea as requested in his reply to the show cause notice and requested to grant him his benefits.

From the perusal of the record placed before the undersigned & heard the version of Sh. Hans Raj, Mandi Supervisor, it is clear that inadvertently the benefit of promotion was given to him and thus the show cause notice issued vide memo No. Admn.II-2017/41931 dated 30.06.2017 for withdrawing the said promotion, is hereby confirmed. If he has suffered, any financial loss due to the promotion, as stated by him during the personal hearing, that should also be rectified as per due process.

Secondly, the Secretary Board is hereby directed to get fix the responsibility of the erring officers/officials who examined the promotion case of Sh. Hans Raj from the post of Auction Recorder to the post of Mandi Supervisor at that time and gave him promotion from considering his date of joining in the year 1984 instead of 1992.


