Shri Mohinder Singh, Sub Divisional Engineer, was issued charge sheet under Rule-2.2(b) of the Punjab Civil Services Rules, Vol.II. read with Rule-7 of the Haryana Civil Services (Punishment & Appeals) Rules, 1987 vide this office Memo No. C&E-II-2072/2016/23136 dated 04.04.2016 and the following charges were leveled against him:-

- 1 That he has got executed lesser width of the road at 3 locations out of 5 test locations.
- 2 The grading of stone metal 53-22.4mm at RD 830m & at RD 1200m on sieve 63mm was found over gauge ranging from 2.76% to 2.73% and grading at RD 1200m on sieve 45mm & at RD 2500m on sieve 22.4mm was found beyond the permissible limit and thus, he caused huge financial loss to the Market Committee/ Board.
- 3 That the grading of GSB-VI at RD 2500m on sieve 2.36mm was found beyond permissible limit and grading of GSB-III at RD 400m, 830m, 1200m, 1800m and 2500m was found under gauge ranging from 18.96% to 25% on various sieves.
- 4 Thus, he has failed to perform his official duties honestly, sincerely and diligently & has violated the provisions laid down under Rule 3(II) (ii) & (iii) of the Work Procedure of the Board & PWD Manual of Orders para 5.5 and Haryana PWD Code, 2009, rule 6.6 & para 20.5.1 and Rule 3(1) (i), (ii) & (iii) and 3 (2) (i) & (ii) of the Haryana Government Employees (Conduct) Rules, 1966.

He submitted his reply to the charge sheet on 21.07.2016 and denied all the charges leveled against him stating that the charge sheet consisting memorandum list of allegations and charges served upon him after his retirement on 29.02.2016. Such charge sheet was required to be served upon him before date of his retirement on 29.02.2016 and not required any reply to the above charge sheet.

To find out the truth, a regular departmental enquiry was entrusted to Sh. R.P. Bhasin, Distt. & Sessions Judge (Retd.) vide order dated 16.06.2016, who submitted his report vide letter dated 25.07.2016 providing all the charges leveled against him. The enquiry report was considered in detail and agreeing with the findings of the Inquiry Officer, a copy of the enquiry report was sent to the delinquent official vide memo No. C&E-II-2016/2072/58901 dated 10.08.2016 with the direction to submit his objections/reply if any, within 30 days from the receipt of this communication.

The delinquent official submitted his objections/reply on 15.09.2016 and denied all the charges/allegations leveled against him stating that on 15.12.2015 the said work was inspected by the 3rd party WAPCOS in the presence of J.E. and agency. At the time of inspection whatever the shortcoming pointed out during the execution of Running work has been rectified and amended later on after the inspection, and further work done as per the direction of 3rd party. ORDER

Sh. Ishwar Singh, Mandi Supervisor, O/o Market Committee, Thanesaee now at Zonal Administrator, HSAMBoard, Hisar was placed under suspension vide this office memo No. C&E-III-2014/1057/2270/97047-59 dated 11.12.2014 and reinstated on 21.04.2015. He was charge sheeted under rule-7 of the HCS (P&A) Rules, 1987 vide this office memo No.C&E-III-1057/2015/15642 dated 12.02.2015. Following charges were levelled against him:-

- 1. That when Sh. Dalel Singh, Secretary-cum-E.O. was working in the office on 05.12.2014 at 02.00 p.m., he entered in his room and started abusing & mishandling with him.*
- 2. That he used offensive/abusive language while making conversation with his senior officer i.e. Secretary-cum-E.O. and thus, his behaviour was unbecoming during office hours.*
- 3. That he was deployed to collect HRDF vide order dated 28.11.2014. but he refused to note that order for compliance and defied the same.*
- 4. That he has violated the provision of rule 3 (1) (i), (ii) & (iii) of the Haryana Government Employees (Conduct) Rules, 1966 and has failed to perform his official duties honestly, sincerely and diligently.*

He submitted his reply to the charge sheet on 14.03.2015. After considering the reply of Sh. Ishwar Singh, Mandi Supervisor, O/o Zonal Administrator, HSAMBoard, Hisar. A regular departmental enquiry was entrusted to Sh. V.P. Batra, IAS (Retd.). The Enquiry Officer has submitted the enquiry report on 30.12.2015 partly proved the charges levelled against him. Accordingly, a show cause notice was issued to him on 02.03.2016.

The delinquent official has submitted the reply to the show cause notice on 22.03.2016 and denied all the charges levelled against him.

The reply submitted by the delinquent was considered in detail and it was decided that an opportunity of personal hearing is required to be afforded to the delinquent before taking final decision of the case.

Accordingly, he was called upon for personal hearing on 26.05.2017 to defend his case.

During hearing, Sh. Ishwar Singh, Mandi Supervisor has repeated the same version as he stated in reply to the charge sheet/ show cause notice.

After going through all the facts/evidence on the record and hearing arguments of the delinquent, I have come to the conclusion that the reasons stated by him are not genuine and authentic. Thus, the charges/allegations are established against him and he can't be go scot free in this case. However, taking a lenient view, he is awarded the punishment of "*stoppage of one increment without cumulative effect*". His suspension period from 11.12.2014 to 21.04.2015 is here by treated as leave of kind due.

He was charge sheeted under rule-7 of the HCS (P&A) Rules, 1987 vide this office memo No.C&E-III-1059/2015/29303 dated 31.03.2015. Following charges were levelled against him:-

- 1. That he was caught red handed while accepting illegal gratification of Rs. 7,000/- from Sh. Sikander S/o Sh. Radhe R/o Village Manpur, Tehsil Hathin, Distt. Palwal.*
- 2. That he has defamed the name of the organisation.*
- 3. That he has violated the rule 3 (1) (i), (ii) & (iii) of the Haryana Government Employees (Conduct) Rules, 1966 and has failed to perform his official duties honestly, sincerely and diligently.*

Sh. Bijender Singh, Ad.Officer (Retd.) (CDC) H.S.A.M.Board, Panchkula was charge sheeted under Rule-2.2(b) of CSR Vol-I, Part-I read with Rule-7 of the Haryana Civil Services (Punishment & Appeal) Rules, 1987 vide memo No. C&E-I-1181/2016/26368 dated 18.04.2016 and the following charges were leveled against him:-

1. **That he misused his official position and concealed the material facts of the case and sent the case file of Sh. Sadhu Ram, Workman for regularization of his services to the competent authority with ulterior motive.**
2. **That he directly submitted the case for regularization of the contractual employees without getting the same processed from the concerned dealing Assistant/ Superintendent, with malafide intention to extend undue benefit of regularization to the contractual employee who was not entitled as per Government policy.**
3. **That his act was totally unbecoming, unlawful & negligent and thus, he has acted in an unprofessional and irresponsible manner and has created untoward situation for the authorities.**
4. **Thus, he has violated the provisions prescribed under rule 3(1) (i), (ii) and (iii) of the Haryana Government Employees (Conduct) Rules, 1966 and has failed to discharge his official duties honestly, sincerely & diligently.**

After receiving and considering his reply vide letter dated 12.05.2016 to the charge sheet, departmental enquiry was entrusted to Sh. V.P. Batra, IAS (Retd.) vide memo dated 25.05.2016, who submitted his findings vide letter dated 17.10.2016 proving all the charges against the delinquent officer. Accordingly, a memorandum dated 10.11.2016 along with a copy of the enquiry report was referred to the delinquent to submit his representation/objections within 30 days from the date of issue of said communication.

The delinquent submitted his reply/objections to the memorandum vide letter dated 15.11.2016 and denied all the charges leveled against him stating that:

1. That as already submitted in his reply to charge sheet, the very charge sheet and all subsequent proceedings are without jurisdiction and illegal and liable to be ignored because Under Rule 2.2(b) under which charge sheet was issued to him after retirement, it is provided that a such charge sheet can be issued only with the sanction of the Govt. Since it was issued without obtaining sanction of the Govt., the charge sheet is without jurisdiction and illegal. As a result all subsequent proceedings are also vitiated by the said illegality. The Punishing Authority failed to deal with the submission while

considering his reply to the charge sheet. Similarly, the Inquiry Officer has observed that since this charge sheet does not relate to causing loss to the Govt., therefore, this condition was not attracted. Therefore, the observation of the Inquiry Officer in this regard is totally wrong and misconceived.

2. That the Inquiry Officer did not observe the mandatory procedure for holding enquiry. The enquiry under Rule 2.2(b) is required to be conducted as a departmental enquiry for imposing a major penalty. In such enquiry, the Inquiry Officer is required to examine prosecution witness and to take on record other material facts in accordance with law. The I.O. has not produced any evidence/material facts in proving the charge against the delinquent officer. It is settled law when no material facts/evidence is produced by the I.O., the cause of action is presumed to have been bad in the eyes of law. On the asking of the then Secretary Board as many as 40 cases have been dealt directly by the delinquent and the competent authority had never objected, meaning thereby it is sufficient evidence. Hence, the delinquent have not dealt cases without the consent of the competent authority and had no bad intention. However, no complaint has been received from the concerned quarters uptill now.
3. The I.O. only recorded the statement of the applicant, thereafter, Sh. Ram Singh, dealing Assistant and Record Keeper produced the record of the case. No other prosecution witness was examined in support of the charges against the applicant. Thereafter, the I.O. himself studied the record produced. The case of Sh. Sadhu Ram is still pending in the Hon'ble High and the matter is subjudice. At this stage, no enquiry Court was required to be conducted.
4. That no evidence has come on record during the inquiry against the applicant. The I.O. recorded the report by just going through the file and various letters has got no value in the eyes of law as it is not based on any evidence and thus, the enquiry report is liable to be rejected.

The case was placed before the Administrative Committee for decision in its meeting held on 10.04.2017 vide agenda item no.8. This case was considered and decided by the Administrative Committee as under:-

“The committee discussed the matter at length and observed that the charges/allegations are established against the delinquent by the I.O. and he is guilty of the charges incorporated in the charge sheet. The proposal made by him for regularization of services of Sh. Sadhu Ram as Peon was not in order and it was not proper on his part to submit the case directly without getting the same processed from dealing Assistant/Superintendent. Thus, he cannot go scot free in this case. However, taking a lenient view the committee decided to award him a punishment of “cut of 2% in pension for one year”.


He is informed accordingly.
