ORDER

Sh. D.C.Sharma and others, Sub Divisional Engineers filed CWP No. 24613 of 2014 in the Hon'ble Punjab & Haryana High Court wherein they have prayed to grant 1st and 2nd ACP on completion of 5 and 11 years of service as SDE and to pay them arrears with interest and also to refix their pension in the case of retired petitioners. This CWP was fixed for hearing on 07.02.2017. The Hon'ble High Court has passed following orders:-

"In the instant writ petition, the grievance of the petitioners is that they have not been granted the benefit of first and second ACP as and when they completed requisite service as Sub Divisional Engineers and further sought for release of arrears, as well as, refixation of pension.

The concerned respondent is directed to consider the grievances of the petitioners and pass a speaking order before the next date of hearing and place it on record on or before the next date of hearing.

List this matter on 07.03.2017.

A photocopy of this order be placed on the connected files of this case."

Briefly stated, facts of the case are that the petitioners were appointed as Junior Engineer and both are diploma holders. Subsequently, they were promoted to the post of Sub Divisional Engineer. The service of the petitioners is/was governed by the Haryana State Agricultural Marketing Board Service Rules, 1974 which were repealed by the HSAMBoard Service Rules, 2008, vide notification dated 04.01.2008. In the HSAMBoard Service Rule, 1974, following provision was prescribed for promotion from Sub Divisional Engineer to the post of Executive Engineer:-

In the Haryana State Agricultural Marketing Board Service Rules, 2008 (Amended 2009), following provision has been prescribed :-

Note: The newly created posts shall be filled up by deputation as these posts are subject to review after two years as per sanction of the Government.

All the employees of the Haryana State Agricultural Marketing Board are governed by the HSAMB Service Rules and in the HSAMB Service Rules, 2008 (Amended in 2009), no diploma holder Sub Divisional Engineer can be promoted to the post of Executive Engineer. Hence, the petitioners are not eligible for promotion to the post of Executive Engineer being not possessing the requisite qualification of BE/B. Tech. or equivalent degree. Secondly, the petitioners have not passed the mandatory departmental test prescribed in the Service Rules for promotion to the post of Executive Engineer.

Further, as per ACP Rules, 1998, only directly recruited Sub Divisional Engineers are entitled for ACP Scale. Since the petitioners were promoted to the post of Sub Divisional Engineer from the post of Junior Engineer, they were not entitled to ACP Scale as per ACP Rules of 1998. Even otherwise, as per the Service Rules of the Haryana State Agricultural Marketing Board, the petitioners are required to pass the departmental examination as prescribed in the Service Rules for promotion to the post of Executive Engineer. But the petitioners do not qualify this necessary condition. The condition of passing of departmental examination for promotion to the post of Executive Engineer was very much there in the Haryana State Agricultural Marketing Board Service Rules, 1974 also and it is still there in the HSAMB Service Rules, 2008 as well. Additionally, as per the Haryana State Agricultural Marketing Board Service Rules, 2008, the SDEs are required to possess a Degree in Civil Engineering for promotion to the post of Executive Engineer. The relevant provision of ACP Rules, 1998 is reproduced herein below for ready reference:-

“5. Eligibility for grant of ACP Scales: (1) Every Government servant who after a regular satisfactory service for a minimum period of 10 years if the minimum period is not otherwise prescribed to be different than 10 years either in these rules or by the government for any class or categories of Government servant from time to time, has not got any financial upgradation in terms of grant of a pay scale higher than the functional pay scale prescribed for the post as on 31.12.1995, on which he was recruited as a direct recruited fresh entrant:

- a) either as a consequence of his functional promotion in the hierarchy, or
- b) as a consequence of the revision of pay scale for the same post, or
- c) as a consequence of any other event through which the functional pay scale of the post has been upgraded, with respect to the functional pay scale prescribed for the post as on 31.12.1995, shall for the purposes of drawal of pay, be eligible for placement into the First ACP scale with reference to him.”

Therefore, as per the Service Rules of the Board, the SDEs are required to have a degree in Civil Engineering and they must also pass the departmental test prescribed by the Board for becoming eligible for promotion

to the post of Executive Engineer. The petitioners are not fit/eligible for the next higher post as they do not fulfill the conditions for promotion.

Further, the provisions regarding eligibility for grant of ACP scale contained under ACP Rules, 2008, are reproduced herein below for ready reference:-

"8. Other general conditions of eligibility of ACP Pay structure:-

The following general conditions shall also be fulfilled by a Government servant for availing benefit of ACP:-

- a) after completing the respective prescribed period for eligibility for the grant of ACP pay structure, the government servant should be fit to be promoted to the next higher post in the notional hierarchy in his cadre, but could not be functionally promoted due to lack of vacancy in the promotional post in the hierarchy to which he is eligible to be promoted.
- b) if such promotion involved passing of any departmental or other test etc., such condition should also be fulfilled by such Government servant."

It is pertinent to mention here that a clarification was sought from the Govt. regarding grant of cadre specific ACP scale to the Engineers of the Board. The Govt. vide memo No.905-Agri. Sec (1)-2015/17152 dated 07.10.2015 has clarified that:-

"Sh. A.K. Jain, Executive Engineer being a Diploma Holder is not fit for promotion to the next post of Superintending Engineer as per the Service Rules, 2008 of Haryana State Agricultural Marketing Board. Accordingly, he is not eligible for grant of cadre specific ACP scale as per Rule-8 of HCS (ACP) Rules, 2008."

From the facts explained above and the provisions prescribed under the rules, it is clear that both petitioners are not qualified for promotion to the post of Executive Engineer and consequently, they are not entitled for grant of ACP scale as well. Hence, their claim for grant of ACP scale after completion of 5 and 11 years' of service is hereby rejected being devoid of any merit.







Description of duties of above mentioned officials:-

Duties of Nodal Officer and Asstt. Nodal Officers of HSAMB for transportation of farmers:

- They will be responsible for transportation of atleast 50 farmers per day per bus to the venue as per the buses allocated to their respective districts.
- They will be in regular touch with the concerned DDA (Deputy Director Agriculture) who will arrange & provide buses free of cost.
- They will be responsible for providing refreshment & food packets in the bus during travelling depending upon the distance travelled by the farmers.
- They will ensure that the banner be collected from the agency engaged for organizing the summit and the same should be properly pasted on the buses of their respective districts coming to the Summit.
- They will ensure to take the registration form from the concerned DDA (Deputy Director Agriculture) and thereafter supply the same to all the Bus Incharges.
- They will monitor timely departure of the buses from their respective districts.

Duties of Bus Incharges of HSAMB:

- They are the Group Leaders in the Buses & will do the registration of the farmers to be boarded in the bus in the “registration form” provided by the concerned Nodal Officer/Asstt. Nodal officer.
- They will accompany the buses & will be responsible for to and fro journey of the farmers.
- They will inform the farmers to board the bus from the same place where they will be dropped at the summit venue & will also inform them the time of departure from the summit venue.
- They will also collect the Coupons for Lunch from the DDA (Deputy Director Agriculture) and provide the same to the farmers.
- They will make sure that they will be in constant / regular touch with the concerned Nodal Officer of HSAMB, DDA (Deputy Director Agriculture) of their respective districts & with the concerned official of the HSAMB posted at the counter of each district at summit venue.

The District-wise list of number of Buses to be arranged and provided by the concerned Deputy Directors Agriculture and Farmers Welfare free of cost of each district is also enclosed for information.







Description of duties of above mentioned officials:-

Duties of Nodal Officer and Asstt. Nodal Officers of HSAMB for transportation of farmers:

- They will be responsible for transportation of atleast 50 farmers per day per bus to the venue as per the buses allocated to their respective districts.
- They will be in regular touch with the concerned DDA (Deputy Director Agriculture) who will arrange & provide buses free of cost.
- They will be responsible for providing refreshment & food packets in the bus during travelling depending upon the distance travelled by the farmers.
- They will ensure that the banner be collected from the agency engaged for organizing the summit and the same should be properly pasted on the buses of their respective districts coming to the Summit.
- They will ensure to take the registration form from the concerned DDA (Deputy Director Agriculture) and thereafter supply the same to all the Bus Incharges.
- They will monitor timely departure of the buses from their respective districts.

Duties of Bus Incharges of HSAMB:

- They are the Group Leaders in the Buses & will do the registration of the farmers to be boarded in the bus in the "registration form" provided by the concerned Nodal Officer/Asstt. Nodal officer.
- They will accompany the buses & will be responsible for to and fro journey of the farmers.

- They will inform the farmers to board the bus from the same place where they will be dropped at the summit venue & will also inform them the time of departure from the summit venue.
- They will also collect the Coupons for Lunch from the DDA (Deputy Director Agriculture) and provide the same to the farmers.
- They will make sure that they will be in constant / regular touch with the concerned Nodal Officer of HSAMB, DDA (Deputy Director Agriculture) of their respective districts & with the concerned official of the HSAMB posted at the counter of each district at summit venue.

The District-wise list of number of Buses to be arranged and provided by the concerned Deputy Directors Agriculture and Farmers Welfare free of cost of each district is also enclosed for information.






