ORDER

Smt. Sunita Devi the then Assistant Secretary, Market Committee, Bahadurgarh was charge sheeted under Rule-8 of the Haryana Civil Services (Punishment & Appeal) Rules, 1987 vide memo No.C&E-I-2017/1162/34525 dated 23.05.2017 and the following allegations were leveled against him:-

"That Sub Divisional Officer (Mech.), HSAM Board, Panchkula vide his note dated 08.07.2015 intimated that an inspection of Market Committee, Bahadurgarh was carried out on 19.06.2015 by the Chief Engineer-I and it was found that the Refuse Collector No. HR-63A-9800 was purchased during the year 2009 for the Market Committee, Bahadurgarh and the machine was not being used since one year by the Market Committee, Bahadurgarh. The reason for non-utilization of the machine was found that work of cleanliness in the Mandi was outsourced to the contractual agency as a result of which the machine was parked idle since March, 2014. During this period, the machine deteriorated and bins were damaged due to negligence of the Market Committee and an expenditure of Rs.73,000/- was incurred on the repair of Refuse Collector machine and bins.

That no information was given by Secretary-cum-E.O., Market Committee, Bahadurgarh to the Head Office with regard to non-utilization of the machine since 2014 nor she made efforts to utilize the machine. Had she intimated timely, the said machine could have been used/shifted to another Market Committee and the said expenditure could also have been avoided.

Thus, Smt. Sunita Devi, Assistant Secretary (Incharge), Market Committee, Bahadurgarh is responsible for the expenditure which has been incurred for the repair of the machine due to long idle parking and non-utilization of the machine. It shows that Smt. Sunita Devi, Assistant Secretary (Incharge) is negligent towards her duties. Such careless attitude is not expected from an officer and it is unbecoming on her part.

That she has violated the provisions laid down under Rule 4(1) (i), (ii) (iii) and (iv) of the Haryana Civil Services (Employees' Conduct) Rules, 2016 and has failed to perform her official duties honestly, sincerely & regularly."

The delinquent officer submitted her reply vide letter dated 15.06.2017 to the charge sheet stating that she informed the head office immediately after outsourcing the cleanliness of mandi vide her office memo No.28 dated 25.04.2014. She discussed the matter telephonically with the then Secretary, H.S.A.M.Board, Panchkula. Reminders letter dated 23.12.2014 and 05.01.2015 were also sent to this office. But no action was taken by the Head office in this matter. The delinquent attended the budget meeting on 02.06.2014 at head office with Smt. Anju Bala, Accountant and personally discussed the matter with the officers. The delinquent was convinced to shift the machine to another Market Committee keeping in view the weak financial position of the Market Committee, Bahadurgarh. The bill of amount Rs.73000/- was not only incurred

because of non-using of machinery but due to continuous use of machinery for five years. The Refuse Collector and the 5 bins were purchased in 2009 which were used up to March 2014. The bins were damaged badly after being used for 5 years. Every machine needs to be repaired after being used for 5 years continuously. The work of cleanliness in the mandi was given to the contractual agency due to lack of staff. The work of cleanliness was being done by two sweepers. One of them was on sick leave. Therefore, the work was given to contractual agency for the sake of smooth functioning in the Mandi during season.

On consideration her reply, she was afforded personal hearing for 01.10.2018 before the competent authority. During hearing, she submitted that the vehicle for Refuse Collector No. HR-63A-9800 remained parked and unutilized because the financial condition of the Committee was poor and the vehicle required one driver, which the Committee could not afford and it was recommended by the Market Committee, Bahadurgarh to the Head Quarter that the unutilized vehicle may be shifted to any nearby Market Committee for its better utilization and accordingly, it was shifted to Sonipat. She discharged her duties in a bonafide way and with no fault of her. She requested that charge sheet under rule-8 against her may be filed.

After going through all the facts evidence on record, statement of allegations, reply of the delinquent, her version during hearing and other documents placed on file, I have come to the conclusion that the correspondence for shifting of vehicle reached Head Quarter only on 30.06.2015. Therefore it is clear that immediate steps were not taken to shift the vehicle. The reasons stated by her are not genuine and authentic and the negligence on her part is proved beyond doubt. Thus, the allegations are established against her and she can't be go scot free in this case. However, taking a lenient view, she is awarded a punishment of "Censure".



Sh. Dharamraj Dangi, the then Secretary-cum-E.O., Market Committee, Bahadurgarh was charge sheeted under Rule-8 of the Haryana Civil Services (Punishment & Appeal) Rules, 1987 vide memo No.C&E-I-2017/1162/34526 dated 23.05.2017 and the following allegations were leveled against him:-

"That Sub Divisional Officer (Mech.), HSAM Board, Panchkula vide his note dated 08.07.2015 intimated that an inspection of Market Committee, Bahadurgarh was carried out on 19.06.2015 by the Chief Engineer-I and it was found that the Refuse Collector No. HR-63A-9800 was purchased during the year 2009 for the Market Committee, Bahadurgarh and the machine was not being used since one year by the Market Committee, Bahadurgarh. The reason for non-utilization of the machine was found that work of cleanliness in the Mandi was outsourced to the contractual agency as a result of which the machine was parked idle since March, 2014. During this period, the machine deteriorated and bins were damaged due to negligence of the Market Committee and an expenditure of Rs. 73,000/- was incurred on the repair of Refuse Collector machine and bins.

That no information was given by Secretary-cum-E.O., Market Committee, Bahadurgarh to the Head Office with regard to non-utilization of the machine since 2014 nor he made efforts to utilize the machine. Had he intimated timely, the said machine could have been used/shifted to another Market Committee and the said expenditure could also have been avoided.

Thus, Sh. Dharamraj Dangi, Secretary-cum-E.O., Market Committee, Bahadurgarh is responsible for the expenditure which has been incurred for the repair of the machine due to long idle parking and non-utilization of the machine. It shows that Sh. Dharamraj Dangi, Secretary-cum-E.O is negligent towards his duties. Such careless attitude is not expected from an officer and it is unbecoming on his part.

That he has violated the provisions laid down under Rule 4(1) (i), (ii) (iii) and (iv) of the Haryana Civil Services (Employees' Conduct) Rules, 2016 and has failed to perform his official duties honestly, sincerely & regularly".

The delinquent officer submitted his reply vide letter 15.06.2017 stating that the refuse collector No. HR-63A-9800 was purchased during the year 2009 which was in use up-to March, 2014 till the mandi was outsourced to the contractual agency for cleaning the mandi. Immediately, after outsourced the cleaning of Mandi the Head Office was requested to shift the machine to another Market Committee vide letter dated 25.04.2014, further reminded on 23.12.2014, again requested vide letter dated 05.01.2015 and again reminded vide letter dated 30.03.2015 by then Secretary-cum-Executive Officer, Market Committee, Bahadurgarh. The delinquent joined Market Committee, Bahadurgarh as In-charge on 01.04.2015 and preparations for wheat season was

in progress and he was busy in the wheat season. Thereafter, he was on medical leave from 30.05.2015 to 14.06.2015 and when Chief Engineer-I inspected Market Committee, Bahadurgarh on 19.05.2015 the delinquent himself verbally informed him about the matter & requested him to shift the machine to another Market Committee and then requested to Head Office for the purpose. The Head Office directed Market Committee, Bahadurgarh vide Memo No. Mech./2015/73839 dated 30.07.2015 to handover the refuse collector to Market Committee, Sonapat with all relevant record of the machine i.e. registration certificate, insurance etc. which was implemented by the delinquent as in-charge of Market Committee, Bahadurgarh.

On consideration his reply, he was afforded personal hearing for 01.10.2018 before the competent authority. During hearing, he submitted that his stay as Secretary, Market Committee, Bahadurgarh was very short, about four months. Therefore, he cannot be made liable for this omission and commission. For the better utilization of the vehicle, it was shifted to the Market Committee, Sonapat during his tenure but after its repair which incurred an expenditure of Rs.73000/-. He discharged his duties in a bonafide way. He further submitted that there was no allegation of irregularity in the repair. He requested that charge sheet under rule-8 against him may be filed.

After going through all the facts evidence on record, statement of allegations, reply of the delinquent, her version during hearing and other documents placed on file, I have come to the conclusion that the correspondence for shifting of vehicle reached Head Quarter only on 30.06.2015. Therefore it is clear that immediate steps were not taken to shift the vehicle. The reasons stated by him were not genuine and authentic and the negligence on his part is proved beyond doubt. Thus, the allegations are established against him and he can't be go scot free in this case. However, taking a lenient view, he is awarded a punishment of "Censure".



ORDER

Shri Sacha Nand, Sub Divisional Engineer (Now Retd.) was charge sheeted under **Rule-8** of the Haryana Civil Services (Punishment & Appeals) Rules, 1987 vide this office Memo No. C&E-II-1977/2016/661 dated **06.01.2017** with following allegations:-

"That the works of special repair of link road from village 'Pingwa to Kapoorwas' and 'Mamlika to Papra' were allotted to Sh. Mohammad Munfed S/o Sh. Naymat, R/o Badli, Tehsil Punhana, District Mewat by the Executive Engineer, HSAMBoard, Gurgaon vide memo No. 2717 dated 22.08.2014 and No. 2598 dated 19.08.2014 respectively. The agency started the work and some of the work was executed by the agency. After that, the agency demanded to release the payment of executed work, but he refused to prepare the bill. Further, it has been alleged that he demanded Rs.30,000/- through Sh. Anil Kumar, Junior Engineer in-charge of work as bribe from the contractor for releasing his due payment.

In this regard, his explanation was called vide Memo No.70 dated 01.01.2016 as to why disciplinary action may not be initiated against him for the execution of the sub standard work at site of work and alleged demand of illegal gratification for preparation/release of the due payment of the contractor and was directed to submit his reply within 7 days positively. His reply was not found satisfactory.

That the work was got executed under his supervision. The works was inspected by the Superintending Engineer (V&QC), HSAMBoard, Panchkula on 09.05.2015 alongwith S/Sh. Subhash Sharan, XEN, Atul Parkash, S.D.E in the presence of the XEN, Gurgaon, S/Sh. Anil Kumar, J.E and Mohd. Munfed, Contractor. 4 nos. samples of PIP blocks at RD 100m, 200m, 300m & 400m were collected and got tested in divisional lab and as per test results, the compressive strength were found 40.36N/mm², 35.77N/mm², 40.23N/mm² and 43.37N/mm² against the requirement of 40.00N/mm². 4 nos. samples of GSB, grade-III materials were taken at RD 100 mtr., 200 mtr. 300 mtr. and RD 400 mtr. The grading of GSB material on sieve 26.05 mm at all the RDs was found overgauge by 26.34%, 12.02%, 11.60% and 8.84% against the requirement of 100% respectively and on sieve 4.75 mm, it was found undergauge by 41.67% at RD 200. Despite sub standard work being executed by the contractual agency, he neither stopped the work nor reported the matter to the higher authorities.

Therefore, Sh. Sacha Nand, Sub Divisional Engineer in connivance with the Junior Engineer and contractual agency, accepted/allowed execution of sub standard work and has failed to get the work executed as per the provisions approved in the DNIT of the work.

Thus, he has failed to perform his official duties honestly, sincerely and diligently & has violated the provisions laid down under Rule 3(II) (ii) & (iii) of the Work Procedure of the Board & PWD Manual of Orders, 5.5 and Haryana PWD Code, 2009 rule 6.6 & para No. 20.5.1 and Rule 4(1) (i), (ii), (iii), (iv) and 4(2) (ii) of the Haryana Civil Services (Government Employees' Conduct) Rules, 2016".



He was asked to submit reply within 15 days from the receipt of memorandum. The delinquent officer did not submitted reply to the charge sheet. In the meantime, the reply of the J.E concerned has been considered; an opportunity of personal hearing was afforded to him on 25.09.2018. Sh. Jayant Sharma on behalf of Sh. Sacha Nand, SDE (Retd.) came in person for personal hearing today. Sh. Jayant Sharma stated that his father was charge sheeted vide memo dated 06.01.2017 for allowing the agency to get the sub standard work. Sh. Jayant Sharma submits during the personal hearing that his father is not able to give further reply of memorandum due to his physical and mental condition and the reply already given may be considered and charge sheet may be filed.

After hearing the arguments and perusing the relevant record of the case, I have come to the conclusion that overgauge material was used at site and payment for sub standard work was allowed/recommended by the delinquent. The recovery of loss on account of sub standard work is itself an evidence in support of truthfullness of the allegations leveled against him. Therefore, the allegations are proved against him beyond any doubt. Though the recovery of Rs.1,80,087/- on account of sub standard work has been made good from the agency, yet laxity on his part in supervising the execution of work is proved. However, taking a lenient, he is awarded punishment of "Censure".

The Supdt.(Admn.) vide his note dated 14.12.2016 intimated that as per attendance register, Sh. Satish Kumar has remained absent from his official duties w.e.f. 01.06.2016 to 12.06.2016, 17.06.2016 to 30.06.2016 and 01.07.2016 to 25.04.2017 without any leave application or prior permission of the competent authority. He was charge sheeted under Rule-7 of the HCS (P&A) Rules, 1987 vide this office memo No.C&E-I-1366/2017/36210 dated 29.05.2017. The following charges were leveled against him:-

1. That he remained wilfully absent from his official duties w.e.f. 01.06.2016 to 12.06.2016, 17.06.2016 to 30.06.2016 and 01.07.2016 to 25.04.2017 without any intimation, leave application or prior permission from the competent authority.
2. That he has violated the provisions laid down under rule 4(1) (i), (ii), (iii) & (iv) of the Haryana Civil Services (Government Employees' Conduct) Rules, 2016 and has miserably failed to perform his official duties honestly, sincerely and diligently.

The official of dispatch section tried many times to deliver the charge sheet to the delinquent official at his home address, but every time his house was found locked and despite best efforts, the charge sheet could not be delivered to him. The charge sheet in question was also dispatched through Regd. Post dated 17.07.2017 but the same was received back undelivered by the post office on 09.08.2017. Thereafter, the same was sent thrice at his residence, H.No.84, Sector-14, Panchkula through the Dak-runner (Peon) of the Board but the same could not be delivered as the house was found locked all the three times.

Thereafter, he was informed through a notice published in Hindi and English newspapers circulated in Haryana State vide memo No.C&E-I-2017/1366/70802 dated 14.11.2017 to obtain the charge sheet from the Dispatch Section of the Board on any working day and submit his reply to the charge sheet within 21 days from the date of publication of the notice, failing

which ex-parte decision will be taken and for that, he himself will be responsible. However, nothing has been received from him so far.

After going through the charges and allegations leveled against the delinquent and all other factors on record, it is established that Sh. Satish Kumar, Peon has remained will full absent from the duty from 01.06.2016 to 12.06.2016, 17.06.2016 to 30.06.2016 and 01.07.2016 to 25.04.2017 and is still absent from the duty without any leave application or prior permission of the competent authority. He has not only bothered to receive the charge sheet, but has also not responded or contacted despite serving a public notice in the newspapers. Therefore, it is clear that he has no interest to serve any service and in such conditions, it would be undesirable also to keep such an official in the service any longer.

Considering, all the facts on record and circumstances of the case stated above, I am of the considered view that continuation of Sh. Satish Kumar, Peon in the service of the HSAM Board is not in public interest. Therefore, Sh. Satish Kumar, Peon is hereby compulsorily retired from the service of the Haryana State Agricultural Marketing Board with immediate effect.



Shri Bajrang Lal, Junior Engineer was issued charge sheet under Rule-8 of the Haryana Civil Services (Punishment & Appeals) Rules, 1987 vide this office Memo No. C&E-II-1968/2015/22699 dated 10.03.2015 with following allegations:-

"That the Executive Engineer, Bhiwani has reported that the work of special repair of link road from Badesra to Bhaini Bheron in Bhiwani Division (ID-417) was allotted to contractor Sh. Davender Singh R/o village Baganwala, Distt. Bhiwani vide memo No. 8473 dated 22.08.2014 by the Executive Engineer, Bhiwani to complete the whole work within three months i.e. upto 21.11.2014. There was a provision of Interlocking Paver Blocks with GSB-III. The site was inspected by 3rd party (GMD) on 27.11.2014 on the request of Executive Engineer, HSAM Board, Bhiwani made vide memo No. 9529 dated 04.11.2014. As per inspection report the grading of Sieve analysis-GSB-III at RD 300m:-

That the material of GSB has been found finer side (under gauge) on sieve 26.5mm is 9.22% and on Sieve 4.75mm is 6.36% at RD 300m and no weep holes provided to the side drains.

Thus, Sh. Bajrang Lal, Junior Engineer in connivance with the contractual agency, has got executed the sub standard work under his



supervision and also failed to exercise proper control over the work at site in order to achieve the good quality of work as per approved DNIT/Specifications.

That he has failed to perform his official duties honestly sincerely and diligently & further violated the provisions laid down under Rule 3(1) (iv), (viii) & (ix) of work Procedure of the Board, PWD Manual of orders para 5.6. and Rule 3(1) (i), (ii) & (iii) and 3 (2) (i) & (ii) of the Haryana Government Employees (Conduct) Rules, 1956."

He was asked to submit the reply within 15 days from the receipt of the memorandum. He submitted his reply to the charge sheet vide letter dated 06.10.2015 and denied all the allegations leveled against him stating that the work was allotted to Sh. Devender Singh, Contractor, Village Baganwala on 22.08.2014 with a time limit of three months i.e. upto 21.11.2014 having provision of interlocking paver blocks with GSB-III. He further stated that the work was executed under his supervision as per specifications. He also stated that during execution, the site was also inspected by the Executive Engineer regularly and necessary test were carried out timely to maintain the quality of work and entered in Quality Control Register. He also stated in his reply that the work was inspected by the GMD consultants on 27.11.2014 and GSB (G-III) was found under gauge in sieve analysis at RD 300m. He further submitted that the method of MORTH specification was used for grading of GSB (G-III) by GMD consultants instead of MORD as per specification of clause-401.

He further stated that the work was again checked by GMD Consultants on 25.01.2015 and GSB (G-III) was found within permissible limit. He further stated that the work was again checked by the Quality Control Wing in the presence of the Contractor concerned and three nos. sample of GSB (G-III) were collected from various places and tested in departmental Lab at Bhiwani in his presence with contractual agency and found slightly over gauge at sieve size 26.5mm which was well within permissible limit. He further submitted that he has performed his duty honestly, sincerely, diligently and has not violated any provision as mentioned in the Charge Sheet. He requested to drop the allegation levelled against him.








After considering his reply an opportunity of personal hearing was given to the delinquent before the final disposal of this charge sheet.

The delinquent officer appeared in this office and reiterated the same version as he stated in his reply.

After hearing the arguments, the relevant record of the case was perused with the assistance of the concerned staff of the Board. I have come to the conclusion that the sub-standard work was executed on the site. However, in view of the submissions made by the delinquent, he is awarded the punishment of 'Censure'.







ORDER

Sh. Deepak Kumar, ASMC, Market Committee, Indri was charge sheeted under rule-8 of the HCS (P&A) Rules, 1987 vide this office memo No.C&E-III-1221/2016/53894 dated 22.07.2016. The following allegations were levelled against him:-

"That as per directions of the C.M.E.O., H.S.A.M. Board, Panchkula, inspecting team consisting of ZMEO, Rohtak, DMEO, Kurukshetra/Karnal, Secretary-cum-E.O., Market Committee, Taraori and other officials inspected Market Committee/Mandi, Indri on 19-10-2015. None of the official of the Market Committee was present to tally the record of heaps. The inspecting team tallied the heaps of paddy lying on the shops of the following firms. with their 'H' register detailed as under:-

The SMC, Indri was directed to take further action against the firms as per rules who failed to record the heaps of paddy in their 'H' register. The DMEO, Ambala & SMC, Taraori also checked the heaps of paddy lying in N.G.M., Indri with the 'H' register of M.C. staff. It was found that 22 heaps of paddy of six firms were not recorded by the officials of M.C which were got recorded in their 'H' register as detailed below:-

sold on 19.10.2015 and had been taken into H-Register of the Market Committee, Indri. There was no evasion of any Market Fee.

The reply submitted by the delinquent was considered in detail and he was afforded an opportunity of personal hearing. During hearing on 25.09.2018, Shri Deepak Kumar, ASMC stated that all the heaps were recorded and only 5 heaps were found unrecorded which might have unloaded late in the evening on 18.10.2015 and these too were related to Govt. purchase. He stated that only 48 heaps were lying in the Mandi at the time of inspection of the team and all were found recorded. He stated that there was no evasion of market fee.

On the other hand, Shri Raj Pal, A.R. stated that on 19.10.2015, he collected market fee/HRDF upto 12.00 noon. As per order dated 11.10.2015 of the SMC, he was issuing gate passes on gate No.4. He has further disclosed that no duty order was issued by the SMC after 11.10.2015. He further stated that he was put on duty of recording arrivals in 'H' register only on 19.10.2015 and that too over telephone by the SMC who was on tour to Chandigarh in connection with some court case on that day. He further stated that 48 heaps were found recorded in the in the 'H' registers of the firms by the inspecting team and only 3 heaps were found unrecorded in the extension Mandi which could not be recorded by him because of vast area of about 45 acres of the Mandi which is not manageable for one official to ensure recording of all arrivals. Regarding 22 heaps of 6 firms found unrecorded by the inspecting team, he stated that he could not record the auction of all the arrivals because the H-register was taken by the inspecting team in their custody. Moreover, he was put on duty at about 12.40 p.m. by the SMC on 19.10.2015 itself and it was not possible for him to record all arrivals which during season start at about 5.00 a.m. in the morning and remain continued till 10.00 p.m.

From the above discussed position, it is clear that the heaps found unrecorded by the inspecting team were because of not deputing of staff on duty by the SMC. Shri Raj Pal has specifically stated that he could not record all the heaps only because he was ordered telephonically by the SMC to do that job on the day of inspection itself at about 12.40 p.m. and it was not possible for him to record all the arrivals in such a short period. He further

admitted that 22 heaps were found unrecorded which could not be recorded by him because the H-register was taken into custody by the inspection team. Whereas Shri Deepak Kumar, ASMC (In-charge) has claimed that all the heaps were found recorded and there was no evasion of market fee.

From the contradictory statements of both the officials, I am in no doubt that the allegation of non-recording of 22 heaps is proved beyond doubt. It is also clear that Shri Deepak Kumar is still trying to mislead. Therefore, considering all the facts and circumstances of the case and taking all the relevant record into account, I am of the considered view that Shri Deepak Kumar, ASMC has been actively involved in facilitating the evasion of market fee by not deputing staff on duty to record the arrivals. However, taking a lenient view, he is awarded punishment of stoppage of two increments without cumulative effect.

I order accordingly.

ORDER

Sh. Raj Pal, Auction Recorder, Market Committee, Indri was placed under suspension vide order dated 07.12.2015 and was reinstated vide order dated 11.04.2016. He was charge sheeted under rule-7 of the HCS (P&A) Rules, 1987 vide memo No.C&E-III-1221/2016/53893 dated 22.07.2016. The following charges were levelled against him:-

- 1. That he has failed to record the arrivals of paddy in the mandi properly, due to which the Board/ Market Committee could have been put to financial loss.*
- 2. That he has violated the provisions of rule 3 (1) (i), (ii) & (iii) of the Haryana Government Employees (Conduct) Rules, 1966 and has failed to perform his official duties honestly, sincerely and diligently.*

He submitted reply to the charge sheet vide letter dated 23.08.2016 and denied all the charges/allegations levelled against him stating that the S.M.C. did not issue written order for 16, 17, 18, 19 and 20.10.2015 and the reason is best known to him. He was allocated the duty to issue gate passes of incoming and outgoing arrivals at gate No.4 as per office order dated 11.10.2015. The duties were changed vide order dated 21.10.2015. The Inspecting Officer checked the register of 13 firms and tallied the entries of 48 heaps found recorded in the H-Registers of the firms. The entry of two heaps of M/s. Mahadev Trading Company as shown at Serial No. 2 and one heap of M/s. Kashmiri Lal Boor Chand as shown at Serial No. 6 have not been found recorded by the firm in their H-Registers. These firms are situated in extension portion of the mandi & he recorded the auction/arrival of these firms after recording the auction/ arrival of main mandi. These firms were found already checked before he met the team. Moreover, the S.M.C. & M.S. were checking the H-Register, weightment as well as stock of the firms. As far as 22 heaps of paddy of 6 firms are concerned, he could not record the arrival/auction because the H-Register was taken into custody by the inspecting team. During the course of checking, he requested the officer to check the H-Register of the firms to confirm the unrecorded heaps but they did not care. As far as the matter of recording of 5 (five) heaps of paddy on the shop of M/s. Sohan Lal Sube Singh is concerned, these heaps were procured by the Govt. agency i.e.

Haryana Agro and he was assigned the duty for recording the arrival/auction of paddy purchased by the private dealers/millers.

After considering his reply, a regular departmental enquiry was entrusted to Sh. Roshan Lal, HCS (Retd.) vide memo dated 27.09.2016. The Enquiry Officer submitted his enquiry report on 30.01.2017 and no charge was proved against the charged official. Disagreeing with the enquiry report, a memorandum along with dissenting note was issued to him vide memo dated 13.08.2018 to submit his representation within 30 days from the receipt of the communication. He submitted reply to the memorandum through e-mail dated 28.08.2018 reiterating the same version as he stated in his reply to the charge sheet and adduced nothing new.

In order to ensure delivery of natural justice, he was afforded an opportunity of personal hearing on 25.09.2018. During personal hearing, he stated that on 19.10.2015, he collected market fee/HRDF upto 12.00 noon. As per order dated 11.10.2015 of the SMC, he was issuing gate passes on gate No.4. He has further disclosed that no duty order was issued by the SMC after 11.10.2015. He further stated that he was put on duty of recording arrivals in 'H' register only on 19.10.2015 and that too over telephone by the SMC who was on tour to Chandigarh in connection with some court case on that day. He further stated that 48 heaps were found recorded in the in the 'H' registers of the firms by the inspecting team and only 3 heaps were found unrecorded in the extension Mandi which could not be recorded by him because of vast area of about 45 acres of the Mandi which is not manageable for one official to ensure recording of all arrivals. Regarding 22 heaps of 6 firms found unrecorded by the inspecting team, he stated that he could not record the auction of all the arrivals because the H-register was taken by the inspecting team in their custody. Moreover, he was put on duty at about 12.40 p.m. by the SMC and it was not possible for him to record all arrivals which during season start at about 5.00 a.m. in the morning and remain continued till 10.00 p.m.

It is clear that 22 heaps were found unrecorded by the inspecting team. But there appears some substance in his version that he could not record all the heaps only because he was ordered telephonically by the SMC to do that job on the day of inspection itself at about 12.40 p.m. and it was not possible

for him to record all the arrivals in such a short period. However, he has admitted that 22 heaps were found unrecorded which could not be recorded by him because the H-register was taken into custody by the inspection team.

Considering all the facts and circumstances of the case and taking all the relevant record into account, I am of the considered view that Shri Raj Pal has been negligent in performing his duty. But keeping in view the fact that he was deputed on the duty of recording of arrivals on the day of inspection itself as about 12.40 p.m. and taking a lenient view in the matter, the case against Shri Raj Pal, A.R. is filed with a warning to be careful in future.







ORDER

Sh. B.S. Dahiya, Sub Divisional Engineer was charge sheeted under rule-7 of the HCS (P&A) Rules, 1987 vide this office memo No. C&E-II/1859/2012/45161 dated 20.07.2012 and the following charges were levelled against him:-

1. That sub-standard work was got executed therefore, the same was rejected for deficiency in thickness and lesser compressive strength, which caused financial loss to the tune of Rs.15,16,237/- to the Market Committee/Board. This casts doubts on his integrity because the entire work was executed under his supervision.
2. That he accepted record entry of defective C.C. work in a length of 840m of the said road to the agency.
3. That he failed to perform his official duties honestly, sincerely and diligently & further violated the provisions laid down under rule-3 (II) (II) & (iii) of Work Procedure of the Board & Haryana PWD Code, para No.20.5.1 and Rule 3(1) (i), (ii) & (iii) and 3 (2) (i) of the Haryana Government Employees (Conduct) Rules, 1966.

The delinquent officer submitted his reply vide letter dated 17.08.2012 and denied all the charges levelled against him. After considering his reply, the departmental enquiry was entrusted to Shri R.P. Bhasin, Distt. & Sessions Judge (Retd.) vide order dated 05.09.2012, who has submitted enquiry report on 06.03.2013, wherein he has proved all the charges against the delinquent officer.

The enquiry report was considered by the competent authority and a 2nd show cause notice was issued to the delinquent officer vide memo dated 14.05.2013 for "stoppage of four increments with cumulative effect besides recovery of loss amount" with the direction to submit reply within 15 days.

The delinquent officer submitted reply to the 2nd show cause notice vide letter dated 14.06.2013 and denied all the charges stating that the Inquiry Officer appointed by your good self as a qualified retired session judge but neither he has any knowledge of technical matters of civil engineering nor he sought any help from any technical expert or civil engineer. He has given so many examples of poem and judgment/decision of Hon'ble High Court and Supreme Court cases where there is no relevancy of these criminal cases/judgment with this case and he got typed 10 pages (3 to 13) in his report and diverted the mind of authority from actual facts of this case. He has stated that the Inquiry Officer attached the statements of all the prosecution witnesses and delinquent as it is and not considered any cross examination and reply given by all the prosecution witnesses in favour of any of delinquent. He has stated that the quality

control team during checking took 7 nos. samples of CC 1:1.5:3 by way of core cutter and found different thickness on each point which was marked on the site plan. The quality control team measured the thickness of CC on the outer edge of road at every RD and found 7"/17.5 cms and prepared a separate site plan on which 7"/17.5 cms thickness as measured at site was marked and both the plans were signed by them. He has stated that facts are that the I.O. is a non technical person and he has not gone through/analysed the checking report submitted by the XEN (QC), test result of samples given by Sh. Ram Institute, New Delhi and even did not bother to read the section 602.15.2 of (MOST) specifications and clause 17.4.3 of IS 456-2000 and code SP: 24-1983. para 16.4 vide which he has submitted his defence reply to the I.O. and he had made his mind that loss was calculated by the officer of the level of S.E. who was holding the CDC charge as S.E. being technical person whereas things are different, who has calculated the loss contrary to the provisions made in MOST specifications and codal provisions even. He has not given proper reply to his question before I.O. during cross -examination. It is a fact that the work was checked in the presence of S/Shri Kuldeep Saini, XEN, B.S. Dahiya, S.D.E and Kuldeep Singh, J.E wherein thickness of C.C. 1:1.5:3 was found 13.58 cm against the requirement of 17.50 cm. Average thickness was wrongly calculated for CC 1:1.5:3 laid at site. The height/thickness observed in respect of C.C 1:1.5:3 by the checking team is available on the 2nd sheet i.e. 7" ht/height on the outer edge.

He has stated that the evaluation of loss as to described in the statement of allegation to the tune of Rs.15,16,237/- is not embodiment of facts by virtue of the inherent future that the test results and site report of XEN (Q.C) and only dart side picture has been taken into consideration and admitted by I.O. without going through the provisions available in the MOST specification. The inspecting team has taken only 6 nos. samples. Thus it did not present the coverage of huge quantity of CC to the tune of 538.01 cum as Sh. Satender Singh, XEN during cross-examination and in reply to question No.4, that the structure should not unnecessarily be declared unfit simply because as clause 16.4 of SP:24-1983. The number of test cores should be as large as possible with due regard to economic consideration.

That even evaluation of loss as alleged/proved by the Inquiry Officer has been worked out @ Rs.3200/- per cum as against Rs.3150/- paid to the contractor in MB No.10590/09. This clearly shows that evaluation has not been done properly without consulting the record by Sh. Satender

Singh, the then SE, Rohtak and even Inquiry Officer has not bothered to consult the record because he has made his mind on the loss worked out by the high level technical person i.e. in the capacity of SE (Rohtak).

The reply to the 2nd show cause notice was considered by the competent authority and decided to seek comments from the Engineer-in-Chief. Accordingly the matter was referred to Engineer-in-Chief (Sh. R.D. Pandir) vide memo dated 10.09.2013, wherein he has pointed out a loss of Rs.13,33,506/- instead of Rs.15,16,237/-.

The comments offered by the Engineer-in-Chief were considered by the competent authority and it was decided to hear him in person. He was heard on 12.08.2014. After hearing, the competent authority decided to seek comments of the Engineer-in-Chief again on the representation submitted by the charged official. Accordingly, the matter was referred to Engineer-in-Chief vide memo dated 21.08.2014, who submitted his comments on 16.10.2014, wherein he has worked out loss of Rs.4,31,737/-.

Lateron, the competent authority has withdrawn all such 2nd show cause notices issued to any employees immediately and sent such memos to them. Accordingly, 2nd show cause notice issued vide memo dated 14.06.2013 was withdrawn and a copy of enquiry report was again sent to the charged officer vide memo dated 06.02.2015 with the direction to submit reply/objections within 30 days.

The delinquent officer submitted his objections vide letter dated 04.03.2015 and stated that he has already submitted his reply on the conclusion made by the enquiry officer vide letter dated 27.06.2013 and same be treated as his final reply/objection.

The objections submitted by the delinquent officer were considered by the competent authority and it was observed that four different officers have calculated/intimated the amount of loss involved in this case and the figure given by them is also different and the matter was referred to Technical Advisor vide memo dated 30.09.2016 for his expert opinion/loss. The Technical Advisor submitted his opinion vide memo dated 18.11.2016 stating that after examination of the process and procedure, it reveals that none of the delinquent officer and the agency had any reservation while selecting and identifying the locations of the checking and the procedure of checking and in his view all the samples taken from the site and the procedure adopted was quite representative and devoid of any demerit. The positions taken by the respective delinquents are an afterthought and devoid of any engineering logic and opined that the enquiry officer had been clearly successful in proving the charges beyond the shadow of all reasonable

doubt. The intention to defraud on the part of the accused and the agency is writ large on the face of the record.

The comments of Technical Advisor dated 18.11.2016 were placed before the Administrative Committee in its meeting held on 24.11.2016. The committee discussed the matter at length and observed that different comments/amount of loss cannot be ascertained. A committee was constituted comprising of S.E. (V&QC), C.E.-I, C.E.-II headed by Technical Advisor. It was directed to re-examine the whole matter thoroughly and submit report alongwith exact loss calculation and clear cut recommendation.

The committee member i.e. S.E. (V&QC), C.E.-I & II submitted their report vide which they have calculated total loss of Rs.8,97,135/- but the Technical Advisor has calculated total loss of Rs.13,33,506/-.

The comments offered by the committee members as well as Technical Advisor were placed before the Administrative Committee for consideration of objections/reply as well as comments offered by the C.E.-II dated 23.06.2014, EIC dated 16.10.2014 and C.E.-II dated 26.08.2016 as well as loss calculated by the committee members as well as Technical Advisor for consideration and appropriate orders.

The case was considered and decided by the Administrative Committee as under:-

"S/Sh. N.K. Bansal, Executive Engineer, B.S. Dahiya, Sub Divisional Engineer and Kuldeep Singh Dahiya Junior Engineer were heard by the committee in person. The matter was discussed in detail and observed that different comments/amount of loss has been pointed out by various senior officers. The committee decided that the loss calculated by Engineer-in-Chief i.e. Rs.4,31,737/- (Four lac Thirty One Thousand Seven Hundred Thirty Seven) be recovered apportioning as per provision/practice.

He is informed accordingly.

The inspecting team has taken only 6 nos. samples. Thus it did not present the coverage of huge quantity of CC to the tune of 538.01 cum as Sh. Satender Singh, XEN during cross-examination and in reply to question No.4. That the structure should not unnecessarily be declared unfit simply because as clause 16.4 of SP:24-1983. The number of test cores should be as large as possible with due regard to economic consideration.

That even evaluation of loss as alleged/proved by the Inquiry Officer has been worked out @ Rs.3200/- per cum as against Rs.3150/- paid to the contractor in MB No.10590/09. This clearly shows that evaluation has



not been done properly without consulting the record by Sh. Satender Singh, the then SE, Rohtak and even Inquiry Officer has not bothered to consult the record because he has made his mind on the loss worked out by the high level technical person i.e. in the capacity of SE (Rohtak).

The reply to the 2nd show cause notice was considered by the competent authority and decided to seek comments from the Engineer-in-Chief. Accordingly the matter was referred to Engineer-in-Chief vide memo dated 10.09.2013, who submitted his comments vide memo dated 23.06.2014, wherein he has pointed out a loss of Rs.13,33,506/- instead of Rs.15,16,237/-.

The comments offered by the Engineer-in-Chief were considered by the competent authority and it was decided to hear him in person. He was heard on 12.08.2014. After hearing, the competent authority decided to seek comments of the Engineer-in-Chief again on the representation submitted by the charged official. Accordingly, the matter was referred to Engineer-in-Chief vide memo dated 21.08.2014, who submitted his comments on 16.10.2014, wherein he has worked out loss of Rs.4,31,737/-.

Lateron, the competent authority has withdrawn all such 2nd show cause notices issued to any employees immediately and sent such memos to them. Accordingly, the 2nd show cause notice issued vide memo dated 14.06.2013 was withdrawn and a copy of enquiry report was again sent to the charged officer vide memo dated 06.02.2015 with the direction to submit reply/objections within 30 days.

The delinquent official submitted his objections vide letter dated 04.03.2015 and stated that he has already submitted his reply on the conclusion made by the enquiry officer vide letter dated 27.06.2013 and same be treated as his final reply/objection.

The objections submitted by the delinquent official were considered by the competent authority and it was observed that four different officers have calculated/intimated the amount of loss involved in this case and the figure given by them is also different and the matter was referred to Technical Advisor vide memo dated 30.09.2016 for his expert opinion/loss. The Technical Advisor was submitted his opinion vide memo dated 18.11.2016 stating that after examination of the process and procedure, it reveals that none of the delinquent officer and the agency had any reservation while selecting and identifying the locations of the checking and the procedure of checking and in his view all the samples taken from the site and the procedure adopted was quite representative and devoid of any demerit. The positions taken by the respective delinquents are an afterthought and devoid

of any engineering logic and in his opinion the enquiry officer had been clearly successful in proving the charges beyond the shadow of all reasonable doubts. The intention to defraud on the part of the accused and the agency is writ large on the face of the record.

The comments of Technical Advisor dated 18.11.2016 were placed before the Administrative Committee in its meeting held on 24.11.2016. The committee discussed the matter at length and observed that different comments/amount of loss cannot be ascertained. A committee was constituted comprising of S.E. (V&QC), C.E.-I, C.E.-II headed by Technical Advisor. It was directed to re-examine the whole matter thoroughly and submit report alongwith exact loss calculation and clear cut recommendation.

The committee member i.e. S.E. (V&QC), C.E.-I & II submitted their report vide which they have calculated total loss of Rs.8,97,135/- but the Technical Advisor has calculated total loss of Rs.13,33,506/-.

The comments offered by the committee members as well as Technical Advisor were placed before the Administrative Committee for consideration of objections/reply as well as comments offered by the C.E.-II dated 23.06.2014, EIC dated 16.10.2014 and C.E.-II dated 26.08.2016 as well as loss calculated by the committee member as well as Technical Advisor for consideration and appropriate orders.

The case was considered and decided by the Administrative Committee as under:-

"S/Sh. N.K. Bansal, Executive Engineer, B.S. Dahiya, Sub Divisional Engineer and Kuldeep Singh Dahiya Junior Engineer were heard by the committee in person. The matter was discussed in detail and observed that different comments/amount of loss has been pointed out by various senior officers. The committee decided that the loss calculated by Engineer-in-Chief i.e. Rs.4,31,737/- (Four lac Thirty One Thousand Seven Hundred Thirty Seven) be recovered apportioning as per provision/practice.

He is informed accordingly.
