Execution of Development Works of Marketing Board/Market Committee-Registration/enlistment of contractors with the HSAM Board

In continuation of this office circular endorsed vide Endst. No. 5474 -5508 dated 8<sup>th</sup> April, 2008, it is informed that the Board of Directors vide item Agenda No. 14 dated 11.2.2010 (copy enclosed for ready reference) have approved the proposal to allow the agencies registered/enlisted with the Housing Board Haryana and Police Housing Corporation to bid in the Haryana State Agricultural Marketing Board by depositing the prescribed fee as in the case of other registered/enlisted agencies who were earlier allowed to bid in the Board.

Further, the Board of Directors after due consideration have also decided to enhance enlistment fee for various categories of enlistment as under:-

This fee will be for a period of two financial year for all the agencies irrespective of their enlistment with any of the organization/institution allowed to bid in the Board and also for those to be enlisted with the Board.

All other conditions shall remain the same.

Execution of development works of Marketing Board/Market Committees - registration/enlistment of contractors with the HSAMB.

In the supplementary Agenda item No.7 dated 20-03-08, it has been approved that the contractual agencies registered with Haryana PWD (B&R), Irrigation, Public Health Department, HUDA, HSIIDC, Power Utilities, CPWD and Railway may be allowed to bid for appropriate category besides enlisted agencies of the Board for the development works being undertaken by the Marketing Board/Market Committees, without getting themselves, registered / enlisted afresh with the Market Board as such, subject to submission of documents at the time of purchasing tender forms. However the contractors/ agencies enlisted with other departments desirous to bid will have to deposit fee once in a financial year alongwith the tender as per rates prescribed in the prospects for the respective class to which the contractor/agency already registered with any other department/ organization mentioned above in case upgradation of the contractor/agency with the previous department during the same financial year it will have to deposit the fee again for the said category in the board. The agencies/contractor willing to bid and not enlisted anywhere shall have to get registered with the board as per procedure laid down in the prospects.

The agencies enlisted with above organizations/Institutions are depositing the fee once in a financial year whereas the Agencies enlisted afresh with the Board are depositing fee once in two years, thus some agencies enlisted with other departments have shown their resentment. To avoid this discrimination the agencies which have been allowed to tender in the Board on the basis of their enlistment in other departments may be considered to tender for two financial years instead of one year as is the case with the agencies enlisted in HSAMB.

While allowing the agencies registered with the above organization/Institution to bid in the Board by depositing fee, the agencies enlisted/registered with Housing Board Haryana and Police Housing Corporation, could not be included. Now it is proposed to include these organizations also besides the above to bid in the Board on the same terms and conditions.

The matter is placed before the Board for consideration and approval, so that prospectus for enlistment of contractors is amended accordingly.
