Organization inviting Expression of Interest (EOI) for applications from Apple Buyers/traders of Haryana/Punjab for the development of Ultra Modern Apple, Fruit and Vegetable Market at Pinjore in an area of 78.33 Acres on National Highway No.- 5. Eligibility Criteria for Type A (Big Shops)

1. Minimum 4 years of experience in Apple Trade, continuously till the last apple season i.e. 2019-20 (Having Valid Wholesale License Issued by their Concerned Market Committee).
2. Minimum turnover of trade valuing Rupees 50 Lakh per annum of Apple Trade (duly verified by Chartered Accountant).

Eligibility Criteria for Type B (Small Shops)

1. Minimum 2 years of experience in Apple Trade, continuously till the last apple season i.e. 2019-20 (Having Valid Wholesale License Issued by their Concerned Market Committee).
2. Minimum turnover of trade valuing Rupees 25 Lakh per annum of Apple Trade (duly verified by Chartered Accountant).

Submission of Expression of Interest:- The interested agencies as specified in eligibility criteria may submit their Expression of Interest addressed to The Chief Administrator, Haryana State Agricultural Marketing Board along with the details of their profile, audited financial report and expertise, in the office of Chief Marketing Enforcement Officer, C-6, Sector-6, Panchkula (Haryana) by 04.08.2020 by 01.00 P.M. Haryana State Agriculture Marketing Board reserves the right to reject or cancel any Expression of Interest without assigning any reason.

Note for Category A Shops:- The above mentioned EOI proposals need to be sent along with Processing Fee of Rs. 10,000/- (Rupees Ten Thousand only) and Earnest Money of Rs. 1,00,000/- (Rupees One Lac Only).

Note for Category B Shops:- The above mentioned EOI proposals need to be sent along with Processing Fee of Rs. 10,000/- (Rupees Ten Thousand only) and Earnest Money of Rs.50,000/- (Rupees Fifty Thousand only).

The Processing Fee and Earnest Money for both type of Shops need to be deposited online or through demand draft, payable at Panchkula in favor of Haryana Marketing Development Fund, Account Number – 35700100000630, Bank of Baroda, Sector-14, Panchkula, IFSC Code – BARBOPANHAR. The Processing Fee is non refundable. The Earnest Money is refundable, if the applicant remains unsuccessful in process of allotment of plots.
