8 teams had been sent to check basic amenities in the mandis of the State as well as preparations made by the Secretaries and the XENs for smooth procurement during the Rabi Marketing Season. These teams had visited the districts allotted and interacted with the concerned XENs, DMEOs, Secretaries and SDOs. They have submitted their reports where a lot of shortcomings have been noticed in the infrastructural facilities like electricity, drinking water, toilets, clearance of platforms & covered sheds, provision of proper boundary walls & gates, functionality of weigh bridges, overall position of drainage system etc.

A copy of relevant inspection report is enclosed. The below-mentioned teams are directed to revisit the earmarked areas again on 13th, 14th and 15th April, 2015. They shall submit their report on 16th April on e-mail address officemdo@yahoo.com, mcellhsamb@yahoo.com and

Beside checking of the basic infrastructural facilities and preparations made for the Rabi Marketing Operations, these teams will also keep a close eye on the recording of arrivals of mustard, wheat and other crops. They would check the relevant documents of the Market Committees, meet farmers and agri-processors like Millers and visit various storage areas where commercial crops like mustard & other oilseeds, commercial basmati rice, guar, etc. are stored. They will check the duty register and arrangements made for enforcement of The HAPM Act and Rules so far as they relate to collection of the Market Fees and the HRDF. Specific deficiencies shall be corrected on the spot and shall also be reported to the Chief Administrator Board.
