Dear sh Avil

You might be aware that in order to make the electoral rolls error free and authenticate the Election Commission of India has decided and directed to feed Aadhaar Number and seed the same in elector's database.

I would like to inform you that the Election Commission has launched nationwide "National Electoral Roll Purification and Authentication Programme (NERPAP") on dated 03.03.2015 and as per existing directions this process is to be completed by 31.07.2015. The Election Commission of India has also set the modalities regarding feeding the Aadhaar numbers by adopting different methods, one of them is through link http://nsvp.in. To achieve the goal Special campaign at various levels are being launched in the State. During the State Level camps the computer professionals/technical employees working in Haryana Civil Secretariat, Haryana Vidhan Sabha Secretariat, Haryana New Secretariat Sector-17, Chandigarh and some Directorates have been trained for feeding Aadhaar Numbers of the employees.

In this context, I would like to refer Chief Secretary to Govt. of Haryana's letter No:4/6/2015-1Election, dated 17th March, 2015 and request to get Aadhaar Numbers of the employees working under your control fed with the Elector's Database. A copy of Advt. containing procedure for feeding of Aadhaar is also enclosed for facilitation by user. Necessary directions may also be issued to all your Field/Subordinate Offices to ensure feeding of their Aadhaar No. as early as possible but before 15th of May, 2015.

I would also request you to instruct them to send an ATR to this office for office record. I shall be grateful for your contribution to this noble cause.
