## Subject:

## Grant of licence of commission agent U/s-10 on part A & B of shops and on booths.

It has been observed that in most Market Committees, number of licences U/s10 are more than the shops available and business has increased manifold in grain markets. In
order to address this situation, the Board has decided in its meeting dated 28.03.2012 that a
maximum of two licences of category II shall be allowed in each shop. However, in case the
mandi is shifted in future, benefit of allotment of shop/plot on reserve price shall be given to
the old/senior of the two licencees.

Regarding booths, the Board decided that:-

- Licences can be granted on booths where open space/private platform is available in front of booths.
- ii) Only single licence will be allowed on the booths.
- iii) If open space/private platform is not available in front of booths but space/private platform of Market Committee is available elsewhere, the Market Committee shall create a designated rental platform if space is available in the mandi. Such designated rental platform shall be used for allowing booth holders who do not have open space/individual platform in front of their booths or licencees who could not get a shop in auction or licensees who are not eligible for getting shops on reserve price by lying user charges/rent which shall be fixed by the Board as per PWD (B&R)' norms. However, such licencees will not be allowed to raise any structure

whatsoever on the designated space. Such designated space shall be given only per season or per year as applicable (such as in Sabzi mandi) and shall be changed every year.

- iv) That out of unsold booths, five booths shall be kept reserved in Mandi for other activities like fertilizers, Bank, ATM, Grocery shops etc.
- v) That in case the Mandi is shifted in future, booth licencees and other categories as mentioned above shall have no right to claim any plot/shop on reserve price.

Secretaries of all Market Committees in the State are directed to issue/renew licencees as per this policy in case of allowing a maximum of two licencees (A & B) per shop.

In case of matters relating to (i) to (v) above, Secretaries of respective Market Committees are to forward proposals through concerned DMEO & ZMEO with due recommendation to the Zonal Administrator for final approval, who will consult DTP of the Board as necessary to determine space before the booth or appropriate space for designated rental platform. In case, space is not available before a booth as described at (i) above and in case, space for rental platform is also not available and if licence has already been issued earlier on such booth, the Zonal Administrator will refer such cases to Head Quarters for final decision after examination of all legal aspects.
