



- (1) These rules may be called the Haryana Civil Services (Pension) Amendment Rules, 2024.
(2) They shall be deemed to have come into force with effect from the 1st January, 2024.
- In the Haryana Civil Services (Pension) Rules, 2016, in rule 40, in sub rule (2), in Note 1, for the words and figure "Rs. 20.00 lakh", the words and figure "Rs. 25 lakh" shall be substituted.

“(11) मृत्यु एवं रोवानिवृत्ति उपदान - मृत्यु एवं रोवानिवृत्ति उपदान की अधिकतम रीमा २ 25 लाख (पच्चीस लाख रुपये) होगी।”

No. 2/14/2018-1 Pension(FD).— In exercise of the power conferred by the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules further to amend the Haryana Civil Services (Revised Pension) Part-II Rules, 2017, namely :-

1. (1) These rules may be called the Haryana Civil Services (Revised Pension) Part-II (Amendment) Rules, 2024.
- (2) They shall be deemed to have come into force with effect from the 1st January, 2024.
2. In the Haryana Civil Services (Revised Pension) Part-II Rules, 2017, for rule 11, the following rule shall be substituted namely:
 - "11. Death-cum-retirement gratuity. --
The maximum limit of death-cum-retirement gratuity shall be ₹ 25 Lakh (twenty five lakh rupees)".
